FIRST CALL – NOTES FROM THE FRONT

WHERE HAVE ALL THE SOLDIERS CITIZENS GONE?

The loneliest job in the world these days has to be that of US Army or Marine infantrymen, and their close ground support comrades. One is hard pressed to find any historical examples of such inattention paid by any nation to the life of its defenders while they suffer and die in battle. It doesn't stop when those of all services come home and need help.

Even during the Vietnam War, citizens were attentive, if disapproving. Today they are disengaged.

"One again a generation of Americans is tempted to live undisturbed, buying tranquility on credit while hearts atrophy, quarantined from any great enthusiasm but private ambition." Bill Moyers

Sadly, even many of our fellow veterans pay little attention to the soldiers themselves, concentrating on the elusive goal of "winning" – without understanding in almost any sense what "winning" as a nation entails. They most often reduce it to the simple concept of "winning" as in a fistfight, or a bar brawl. They hoot and holler with ramped-up nationalistic vigor at the thought of our soldiers "winning", meaning beating the daylights out of "them" – "the other guys".

The picture many of us older, and dare I say more thoughtful veterans and citizens have of the American soldier is as the defender of a bright and clear vision of equality, freedom, democracy, and fairness. We see the soldier more like Gary Cooper in *High Noon* – quiet, reserved, fair, thoughtful, professional, hard to provoke, firm in his convictions, deadly in his execution, then benevolent in his victory.

The view of those who hold the ferocious warrior or even the *berserker* concept of the soldier, is as relentless, quick to anger, violent and bloody in execution, giving no quarter, and holding an eternal

grudge against those who dare challenge him or his nation. The model is Mel Gibson as "Mad" Max in *Beyond Thunderdome*, or worse yet the Lord Humungous from the same film.

Don't get me wrong. This latter view, I am sure, is not how most soldiers view themselves, rather it is how a disengaged and self-pampering public views them, when they bother to think of them at all. Unfortunately it comes close to how some of our fellow veterans view them as well. Just read some of the blogs and the websites if you don't believe me. The blood-lust is palpable, and the language praising our soldiers sounds like an advertisement for a super-violent MA-rated video game. But ~

So one model is that of maturity, strength, wisdom. The other model is that of the comic book super-hero-turned-slayer.

Those other guys may be right, at least in part. We only need to look at some of today's reality TV to find a metaphor. Take the Spike TV "Ultimate Fighter" cage-fighting series as a fair example.

It's 2003 and two fighters are in the cage. One well-armed but not perfectly; a rested, strong, and fully supported heavyweight faces up against the other, a poorly trained poorly armed lightweight. The battle is over shortly, and the ring attendants slip the noose around the loser's heels and drag him from the arena like a defeated bull at Madrid's *Las Ventas* bullring. His leaders and supporters declare "Victory" but they are wrong.

Let's extend the metaphor and make it more like 2003 – 2008's real battle. We leave the winning fighter in the cage – the gate is locked. We improve his armor from time to time and give him a new weapon or two, but he cannot leave the cage. The cage is brilliantly lighted but the spectator area outside the cage is pitch black. He believes that his fellow citizens are still out there watching and rooting for him.

The lights outside the cage are flashed on for a moment and he sees the truth. His fellow citizens aren't even there anymore. He has new opponents but they are outside the cage armed with sniper rifles and roadside bombs. He can't see them but they can see him only too well. His leaders are only present in order to act or fail to act in a way to ensure that the supply of foes is steadily increased. After all, we need a continuing war to be able to claim war-leadership.

When our soldier asks for help, the handlers occasionally send in another soldier, but he or she too is locked in the bright cage in the dark stadium, and is subject to the same attacks from unseen foes.

When our soldier asks for more help, he is given some money and by pushing it through bars of the cage he is able to buy off a few, but not all of his foes, and the attacks continue with some relief from at least one quarter. When he runs out of money, or his leaders act to ramp up the rage of his foes, the bought-off ones resume their attacks.

The cage is impregnable from his side as it is made of political choices that cannot be retracted. His cage and his way out of it are based on a policy of "winning", but no one can explain that policy to him – no one knows what the hell "winning" means! The key to the cage is hidden in the undefined goal.

The outer lights flash on now and then, briefly, and still there are none of his fellow citizens there to cheer him on, much less to aid him, and certainly not to involve themselves. The seats reserved for them remain empty – reserved, of course, in recognition of their importance, but empty nonetheless..

If he is killed he is sent home but hidden from view. When he is wounded he is replaced, and sent home to find yet another cage.

This time he is outside the cage and the cage door is locked, for inside it are those who make the money, have the power, and hand down the decisions that control his life. They post long lists on the outside of the cage of the benefits available to him, but the

benefits are inside this home cage, and he has to fight to get inside.

He isn't allowed to get any help in getting through this cage wall, while those inside stack up the regulations that reinforce those walls, and they line up the new foes – those who make him fight this new battle once again all alone – those who hand down the arbitrary decisions that govern his life for good, or more often for ill.

These are the keepers of the new cage who talk about "average wait times" and "budget limitations", interspersed with "Support the Troops" and "Honor the Veteran" speeches. They will only listen to him long enough to tell him that the wound he suffered or those horrific dreams he is having are not combat-related unless he can provide proof that he was once in combat, and that that specific time resulted in his problem. Somehow he forgot to take notes.

Deep inside the home cage there is an inner ring of all those of his fellow citizens who were rooting for him in the first few weeks of the conflict, but who disappeared from the audience around the original battle cage. They are surrounded by all of the amenities of the self-indulgent life. They shop at stores with banners hawking their "Veterans Day Sale" and their "Memorial Day Sale". They are surrounded by a soundproof wall that excludes his pleas for help. Their televisions don't have a channel that shows the outside of the cage. The ads for their high-priced goodies and their fanciful vacations appear daily in the paper many pages before the occasional article about the soldier and his comrades.

Our veteran soldier tries to find a copy of the US Constitution – the document and the idea that he had sworn to defend, and which he believed also defended him. To no avail. Those in the inner circle had burnt every last copy back at the beginning to keep them from being uncomfortable on chilly and scary nights.

In the end, the soldier gives up and fades away. He walks away from the cage, looking back over his shoulder to read the inscription over the cage door:

America - Land of the Happy - Home of the Indulgent
~~~  
No entry to veterans - closed for repairs indifference

### **WHY WAS THE DAV (DISABLED AMERICAN VETERANS) EXCLUDED FROM WALTER REED? – THEY WERE TELLING THE TRUTH!**

[When leaving the service because of wounds or injuries] a **Medical Discharge** should be the goal and probably the reason the DAV was excluded from Walter Reed....they were doing their job and correctly advising the Iraq and Afghanistan vets to **Refuse** honorable discharges and insist instead on medical discharges under honorable conditions. Contrary to misinformation [from other sources], any vet who has served 180 days or more, and [who] cannot be returned to military duties, can be given a medical discharge under honorable conditions and [the vet] will be eligible to get care at **both military hospitals and clinics and VA facilities**. **KEY** to this is that the vet **MUST** be willing to refuse an honorable discharge when offered! The military’s reps will try to get the vet to take the honorable discharge, as a medical discharge could cost the military a lot of money in long term medical care and they [prefer] to transfer the expense to the VA. ~ Lane Anderson

## **RECALL - FEDERAL AND STATE LEGISLATION AND LEGISLATORS**

### **REDUCED RETIREMENT AGE FOR RC SOLDIERS**

The National Defense Authorization Act of 2008. [passed in January 2008] made Reserve Component (RC) soldiers eligible for reduced retirement age based on active duty service after the passing of that act. They were not grandfathered to be eligible for all their service since the beginning of current hostilities.

Senator Chambliss, (R-GA) introduced legislation in 2007 to make the eligibility retroactive to 9/11/2001. The services opposed the legislation. The bill has been in committee 18 months since its introduction.

**National Guard and Reserve Retirement Modernization Act** - Amends federal law concerning receipt of retired pay for non-regular service to provide that, in the case of a member of the Ready Reserve who serves on active duty after September 11, 2001, in support of a contingency operation or in response to a national emergency, retirement eligibility age shall be reduced below 60 by three months for each aggregate of 90 days during which the member so performs in any fiscal year after such date. Prohibits such retirement eligibility date from being reduced below age 50. Continues age 60 as the minimum eligibility age for DOD-authorized health care for such retirees.

### **CONGRESS MUST ACT TO RESTORE EARNED BENEFITS TO ALL VIETNAM VETERANS – INCLUDING “BLUE WATER” VETS!**

Washington, D.C. – House Veterans' Affairs Committee Chairman Filner (D-CA) held a press conference to announce the introduction of [H.R. 6562](#), the Agent Orange Equity Act of 2008.

"We owe it to our veterans to fulfill the promises made to them as a result of their service," said Chairman Filner. "If, as a result of service, a veteran was exposed to Agent Orange and it has resulted in failing health, this country has a moral obligation to care for each veteran the way we promised we would. And as a country at war, we must prove that we will be there for all of our veterans, no matter when they serve. The courts have turned their backs on our veterans, but I believe this Congress will not allow our veterans to be cheated of their earned benefits."

### **CONGRESS PASSES FEINSTEIN-CHAMBLISS-NUNES-COSTA LEGISLATION TO PROTECT BENEFITS OF AMERICA'S MILITARY "SOLE SURVIVORS"**

Washington, DC 1 August 2008 –The U.S. Senate today gave final approval to the Hubbard Act, to protect the benefits of America's military "sole survivors," introduced by Senator Dianne Feinstein (D-Calif.), Senator Saxby Chambliss (R-Ga.), Representative Devin Nunes (R-Calif.), and Representative Jim Costa (D-Calif.).

The legislation is named in honor of California's Hubbard brothers. Jared and Nathan Hubbard lost their lives serving their country in Iraq. Jason Hubbard was discharged as a sole survivor, but was denied separation benefits when he left the Army early to return to his job as a Fresno County sheriff's deputy.

The legislation will provide sole survivors a number of benefits already offered to other soldiers honorably separating from military service. In addition, sole survivors will not be required to repay any portion of their enlistment bonus; may participate in the Montgomery GI Bill educational program; and may receive separation pay and transitional healthcare coverage.

The bill passed by the House earlier in the week. It now heads to the White House for the President's signature.

### **CALIFORNIA NATIONAL GUARD LOSING BUDGET BATTLE IN LEGISLATURE**

Democrats in the state Senate block a \$3.3-million allocation to give educational benefits to Guard members.

SACRAMENTO — While they have been beating back wildfires across the state and fighting wars on two fronts overseas, the citizen soldiers of the California National Guard have also been waging a battle in the Legislature -- and losing. For the second year in a row, state lawmakers have rebuffed the Guard's effort to win state money to help cover the cost of college for its members. State military officials say their only hope now is that Gov. Arnold Schwarzenegger will prevail upon Democratic legislators to include money for tuition assistance in the budget that is 49 days overdue and more than \$15 billion in the red. California is the only state that gives no educational benefit to National Guard members.

### **ATTEMPT TO STOP GIVE-AWAY OF VETERANS PROPERTY IN LOS ANGELES**

The West Los Angeles VA Medical Center was given to the government and the people of the United States by Arcadia Bandini de Baker and John P. Jones. Those two donated the acreage to the federal government in 1888 for a for use in perpetuity as a National Soldiers Home for veterans of the Civil War.. The VA has been giving away bits and pieces over the years and since 2005 has been attempting to sell much of the property off to commercial developers.

On 17 May 2007 Senator Feinstein (D-CA) introduced [S. 1417](#), a bill "to direct the Secretary of Veterans Affairs to submit a report to Congress providing a master plan for the use of the West Los Angeles Department of Veterans Affairs Medical Center, California, and for other purposes." The bill was referred to the Committee on Veterans' Affairs and no further action has been taken.

### **STATE MILITARY FUND SITS IDLE**

With patriotic fanfare, state lawmakers set aside \$5-million in 2005 to help families of deployed Florida National Guard and Reserve troops facing financial difficulties. But thus far, just \$606,907 has been paid out to 172 citizen soldiers and their families. In the last year, payments slowed to a trickle with just \$128,000 paid to 32 families in need. No news conference trumpeted what happened on July 1: Lawmakers took back most of the money, reducing the fund to a mere \$400,000.

#### IRAQ GI AT WAR OVER KIDS ON HOMEFRONT

Like most good dads who are away from home, Jonathan Maldonado tried phoning his daughter on her birthday in June. But hearing his 2-year-old's adoring voice wasn't going to happen.

Not just because the Bronx dad has been in Iraq with the 3rd Armored Cavalry fighting America's enemies since late last year. Rather, he was knee-deep in a quagmire with the Administration for Children Services. Maldonado's problems began with his custody battle with estranged wife Elsa Ruiz, 22, over their two children. ...In August 2007, Ruiz retained custody of the kids because Maldonado - then stationed at Fort Hood, Texas - was designated an absent parent during a Bronx Family Court custody petition.

"They claimed he had no rights to the children because he was not in the picture," said Jackie Lugo, 41, the soldier's mother. The dad's problems worsened when Ruiz eventually yielded control of the kids to an ACS foster parent while he was stationed in Iraq, family sources said. Since then, Maldonado said, an ACS agent told his family that he had "no right to know" where his children were and that the ACS repeatedly ignored his anguished calls from overseas.

#### MILLIONS LOST ON CONSTRUCTION PROJECTS

Millions of dollars were likely wasted on a 900 million dollar army contract to build courthouses, prisons, police and other security facilities in Iraq, an audit released Monday has found.

The audit by the congressionally appointed Special Inspector General for Iraq, Stuart Bowen, found that the contractor, Parsons Delaware Inc., completed only about a third of 53 planned construction projects.

"Although the failure to complete some of the work is understandable because of its complex nature and the unstable security environment in Iraq, millions of dollars in waste are likely associated with incomplete, terminated and abandoned projects under this contract," the audit report said. <More at: <http://www.capitolhillblue.com/cont/node/9923>>

#### ARE CONTRACTORS IN WAR ZONES ABOVE THE LAW?

In January of 2008, Staff Sgt. Ryan Maseth, 24, was electrocuted while showering in his Baghdad barracks. His death prompted last week's [congressional report](#) concluding that defense contractor KBR, (until a year ago a subsidiary of the oil services giant Halliburton) [was well aware that the electrical system in Maseth's complex was faulty](#). An accident like this, the report found, was bound to happen. But this report also now raises a larger and thornier question about military defense contractors: can they be held legally liable for their actions -- or inactions? Will anyone be held responsible for Maseth's death?

... the Pentagon inspector general's interim report provided to the House Oversight Committee on July 28 said it "has not found any credible evidence that representatives from KBR were aware of imminent, life-threatening hazards" in Maseth's complex prior to his death. #### ENDING 'THE WAR ON TERROR'

The federally-funded RAND Corp. -- a public policy research institute that counsels the Pentagon -- [released a study](#) this week examining "how terrorist groups end" and concluded that the United States can defeat al Qaeda but only if it relies less on the use of military force and more on policing and intelligence. RAND conducted a quantitative analysis of 648 terror groups that existed between 1968 and 2006 and found that "most groups have ended because (1) they joined the political process or (2) local police and intelligence agencies arrested or killed key members. Military force has rarely been the primary reason for the end of terrorist groups." While nearly half of the terror groups analyzed ended as a result of a transition into the political process, for those "that cannot or will not make a transition to nonviolence, policing is likely to be the most effective strategy." The study noted that "[a]fter September 11, 2001, the U.S. strategy against al Qa'ida centered on the use of military force" and

that "U.S. policymakers and key national-security documents referred to operations against al Qa'ida as *the war on terrorism* [emphasis in original]." However, the study added: "The evidence by 2008 suggested that the U.S. strategy was not successful in undermining al Qa'ida's capabilities." <More at: <http://pr.thinkprogress.org/>>

### **U.S. MARINES ORDERED TO REMAIN IN AFGHANISTAN**

The US and NATO struggle to maintain troops even as the Taliban reclaim southern and eastern Afghan provinces. With Afghanistan now more dangerous for foreign troops than Iraq, the United States military decided this week to bolster the presence of US Marines in the country.

The move, the latest in a series, comes just three days after five North Atlantic Treaty Organization (NATO) soldiers were killed in a series of roadside bombings in Afghanistan that underscored the Taliban's resurgence in the country's southern and eastern provinces. The increased deployments indicate the US's mounting frustration with NATO for not providing more troops to tackle the Afghan insurgency.

The US Defense Department announced yesterday that it would extend by one month the tour of 1,250 Marines, the second such decision in as many months, according to the Associated Press. The decision to extend the tour of the 2nd Battalion, 7th Marine Regiment in Afghanistan comes just a month after defense officials told the 24th Marine Expeditionary Unit that it would stay an extra month in Afghanistan. <More at: [www.csmonitor.com/2008/0805/p99s01-duts.html](http://www.csmonitor.com/2008/0805/p99s01-duts.html)>

### **VA GETS 55,000 PLUS SUICIDE CALLS**

More than 55,000 people - including about 22,000 who identified themselves as veterans - have called the Department of Veterans Affairs' suicide hotline during its first year in operation and CBS News has learned that many of the calls, in recent months, have come from the mid to south central part of the country.

According to the VA's own count, during a three month time period between March and May of this year, the regions where the highest number of calls originated include the states of Texas, Tennessee, Illinois and Florida among other surrounding areas. (California and Florida have the nation's largest veteran populations.)

### **FATAL MRAP ACCIDENTS PROMPT WARNINGS**

The towering trucks that give U.S. troops the best protection against roadside bombs and enemy bullets also make them vulnerable to routine hazards like sharp turns, rutted roads and rickety bridges. Five deaths caused by rollovers and dozens of other accidents in Iraq and Afghanistan have led U.S. military leaders to warn troops to be smart behind the wheel, according to military documents obtained by The Associated Press and accident reports released under the Freedom of Information Act.

The message is especially relevant in Afghanistan, where a resurgent Taliban has boosted demand for these steel cocoons, known as MRAPs. ### **PREDATOR PILOTS SUFFERING WAR STRESS**

MARCH AIR RESERVE BASE, Calif. - The Air National Guardsmen who operate Predator drones over Iraq via remote control, launching deadly missile attacks from the safety of Southern California 7,000 miles away, are suffering some of the same psychological stresses as their comrades on the battlefield. Working in air-conditioned trailers, Predator pilots observe the field of battle through a bank of video screens and kill enemy fighters with a few computer keystrokes. Then, after their shifts are over, they get to drive home and sleep in their own beds. ### **STRAINED BY WAR, U.S. ARMY PROMOTES UNQUALIFIED SOLDIERS**

According to a Salon investigation, the Army is facing a troubling shortage of qualified sergeants, the noncommissioned officers considered to be the backbone of training and combat operations. In fact, a new Army policy intended to boost this critical leadership corps of NCOs has prompted a wave of promotions for apparently unqualified soldiers -- and even jeopardized some combat operations in Iraq.

In essence, an Army policy implemented in 2005 and expanded this year lowered the bar for enlisted soldiers with the rank of E-4 to gain the rank of sergeant, or E-5, by diminishing the vetting process. According to more than a half dozen current and former Army sergeants interviewed by Salon, the policy has produced sergeants who are not ready to lead. In some cases, soldiers were promoted even after being denied advancement by their own unit commanders. While awarding a promotion once required effort on the part of a commander, those interviewed say, the Army's current policy actually requires effort *to prevent* a promotion, and has had negative consequences on the battlefield.

WASHINGTON (AP) \_ The Army is mailing out thousands of letters to survivors of soldiers killed in Iraq and Afghanistan, asking what it can do to better help them, even years after the deaths of their loved ones. The Army recognizes it's made mistakes in some of its dealings with the families of fallen soldiers, Col. Carl M. Johnson, director of the Army's Casualty and Mortuary Affairs Operation Center, said in an interview. And the letter, a copy of which was obtained by The Associated Press, encourages families to be candid in their comments and suggestions.

About 13,500 letters have been sent this month, and copies are expected to reach about 20,000 survivors of those killed while on active duty with the Army since the Sept. 11, 2001, terrorist attacks — either in a war zone, in the United States or elsewhere. ### **WHY SOLDIERS RAPE**

Army Capt. Jennifer Machmer testifies before a congressional caucus that she was assaulted in 2003 in Kuwait by another U.S. soldier. An alarming number of women soldiers are being sexually abused by their comrades-in-arms, both at war and at home. This fact has received a fair amount of attention lately from researchers and the press — and deservedly so.

But the attention always focuses on the women: where they were when assaulted, their relations with the assailant, the effects on their mental health and careers, whether they are being adequately helped, and so on. That discussion, as valuable as it is, misses a fundamental point. To understand military sexual assault, let alone know how to stop it, we must focus on the perpetrators. We need to ask: Why do soldiers rape?

Rape in civilian life is already unacceptably common. One in six women is raped or sexually assaulted in her lifetime, according to the National Institute of Justice, a number so high it should be considered an epidemic. In the military, however, the situation is even worse. Rape is almost twice as frequent as it is among civilians, especially in wartime.

Day after day, the soldiers march into Catherine Morris's office at Sierra College in Rocklin.

They bring the familiar baggage of student life: Worries about whether they are majoring in the right subjects.

Concerns about juggling work and classes. Questions about how they might improve their English grades.

Most of the young men and women who visit Morris have done time in combat. Their scars run deep, but are not always visible.

Looking into their eyes from behind her neatly organized desk in the school's campus center, Morris sees more than most. A former Marine who keeps a photograph of her younger self in uniform on a shelf, she runs a year-round program specifically designed for veterans going to school under the GI Bill.

... "Some of these veterans are truly more afraid of going to college than they were of going to Iraq," said Morris, who has served in the Army National Guard and the California Air National Guard as well as the Marines. "They are so overwhelmed, and they feel very isolated."

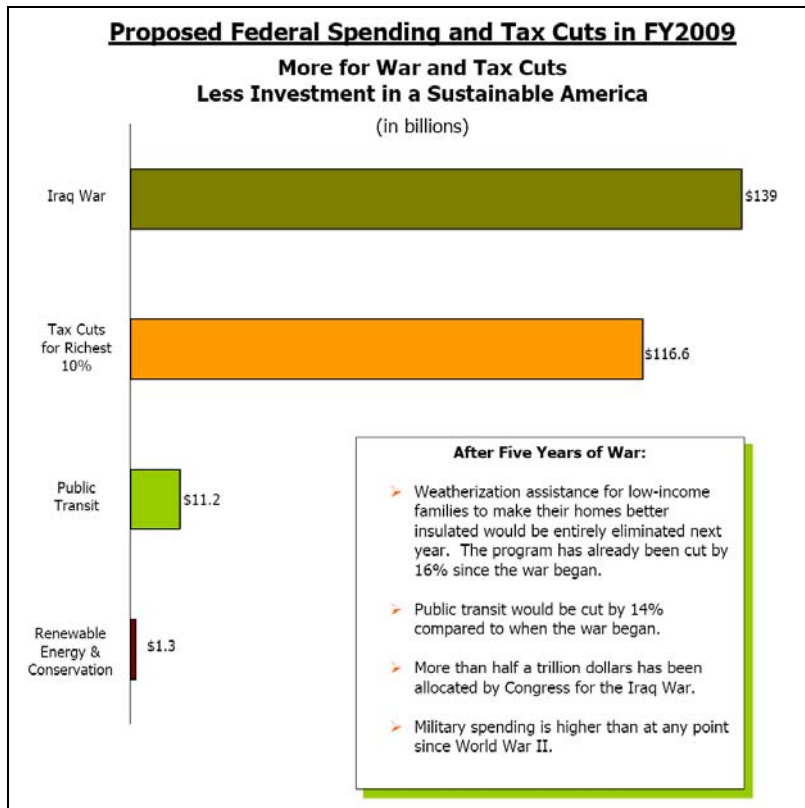
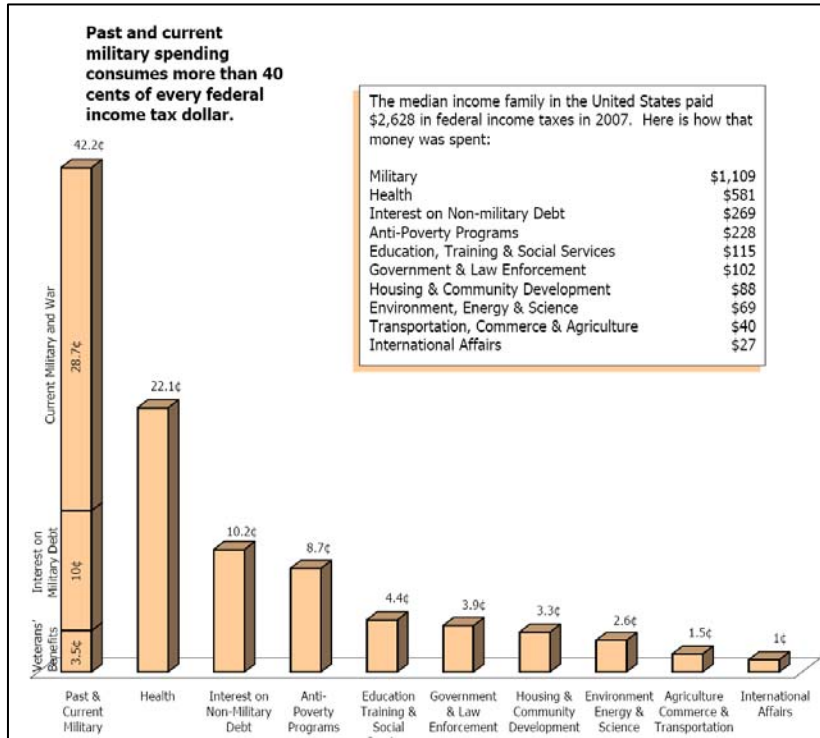
