## FIRST CALL - NOTES FROM THE FRONT

#### THIS WE'LL DEFEND II

Last issue I talked about the Army's motto, "This We'll Defend", and how we veterans swore that oath to defend the Constitution even against domestic enemies.

In the ensuing month I have received a number of responses, as well as a number of outside comments and articles from myriad sources on the meaning of the Constitution, originally and in today's world.

If I could reproduce all of them here your head would spin trying to sort out the various views of what the Constitution means, and how we should be applying it today.

The comments range from the radical right to the loony left and every shade in between. The difference in the views expressed in these missives staggers the mind. You would be hard-pressed to show that they were reading the same documents.

If you were to read across the whole range of opinions (it was all opinion, no scholarship) you would find that we Americans don't have a very good idea of what is really in our Constitution. Further, we don't seem to understand what the founders really did to give it to us, and how they went about it.

Even more than that, many of us seem to believe that the Constitution absolutely and inarguably supports our personal ideological convictions, regardless. In no group was that view more prevalent in these emails than in our fellow veterans.

Why is it important that we veterans study and understand, at least to the level of educated laymen, what the US Constitution means,?

Maybe one answer to that is, "Because our fellow citizens don't do it!" Maybe the better answer is,

"Because we swore to defend it, therefore we are obliged to understand it, and how it came about."

Without that latter answer we would have to say that we swore to defend something we knew nothing about, and that is not our way, is it? That just doesn't do it for you or for me.

The reaction to that article sent me back to the books, and I re-read one book that I first read 40-some years ago, and read another that was new to me, although it is 25 years old.

The first book, Catherine Drinker Bowen's "Miracle at Philadelphia" is, in the words of Henry Steele Commager, a renowned historian, "The most readable of all accounts of the Philadelphia convention." It lays out in great but readable detail the workings of the Constitutional Convention from 25 May to 17 September 1787.

The second book is Ralph Ketcham's "The Anti-Federalist Papers and the Constitutional Convention Debates", which covers some of the same ground but concentrates on the arguments <u>against</u> the Constitution.

When some politician says, "The Founders wanted [*some simple point*]", you can be fairly sure that he or she hasn't read much about "the Founders". The simpler the point they are trying to make, the more likely they are to be either dead wrong or lying.

Had he or she read these two books, and were they presenting the complexity of their issue, then you could probably trust them. One thing for sure, there were no simple answers then and there are none now.

Those "Founders" who either supported or opposed the Constitution did so for varied reasons. Some supported the rights of people, some supported

the rights of property, some supported the rights of states.

Some of those who supported the rights of people often ended up opposing the Constitution because it did not contain a Bill of Rights.

Some who supported the rights of property ended up opposing the Constitution because it did not, in their view, protect the rights of wealth and property sufficiently and might make property subordinate to individual rights.

Those who supported the rights of states operated on the belief that the original Confederation was as "United" as these states should ever be, and were jealous of any powers that would be transferred from the states to the central government.

Some were afraid of an executive that would end up becoming a monarchy. Others were inclined to believe that monarchy wouldn't be a bad idea and considered offering the kingship to George Washington.

Many were afraid of a legislature that would allow a government, under the influence of "the common people", to confiscate or overly tax property, while others were afraid of a legislature that would aid entrenched powers to subordinate the people.

Most were afraid of a Supreme Court that would override the laws and the courts of the states.

Both sides were afraid of a loss of freedom of belief. The Catholics of Maryland and the Quakers of Pennsylvania were particularly afraid, but then, there were many Protestants who were afraid either of the "papists" or even of other Protestant denominations, especially of Episcopalians. In the end, freedom of conscience and belief was a strong point for both sides (despite some current arguments to the contrary).

To confuse the issue the "Founders" lined themselves up as: 1) the "Federalists" who were in favor not of a federation but of a unified central government; and, 2) the "anti-Federalists" who were in favor of continuing the original federation. Even the names of their groups didn't reflect their views.

Every side of the argument cited the "lessons of history" as the rationale for its positions. Each camp took selectively from history going back to Mesopotamia, and the Macedonian and Roman Empires. Each also tended to draw different conclusions from the same data.

Both sides agreed that the Confederation was faulted and needed to be fixed: their answers were

markedly different—the "anti-Federalists" to modify it, and the "Federalists" to change it.

The Federalists took their historical lessons from near British history, showing that not only was it possible to govern widely across the land, but also that central government was the best sort of government to preserve the rights of the people, and to present the nation to the outside world.

The major historical lesson that the anti-Federalists used was from various empires showing that empires tended to be too big to govern. They cited Montesquieu as stating that democracy would only work on a small scale, and that large scale government could only be viable through military-enforced despotism.

If we veterans are to engage in a knowledgeable discussion about the Constitution and its meaning for us today, there are several important points to be derived from a study of this monumental and often confusing chain of events:

- 1. The "Founders" were all over the map on the issues at stake.
- 2. The "Founders" often joined different camps on different Constitutional issues.
- 3. Some of the "Founders" were adamant central government supporters while others were just as avid in their support of decentralized government based on the states.
- 4. Some of the "Founders" were in favor of a Bill of Rights, but others were strongly in favor of not including it as they believed that the rights didn't need protection since they were inherent. Others even believed that a statement of rights would cause mischief later as the people got a little too uppity.
- 5. Some were in favor of a strong Senate, consisting of "the proper sort", and a weak House consisting of "ordinary people", with the Senate being the final arbiter on everything.
- 6. Almost all were against a standing army although they saw a need for a fleet to protect shipping interests.
- 7. Almost all feared a too strong executive.

Their arguments for and against ratification went on from September 1787 until the final state (RI) ratified the Constitution in May 1790.

The arguments on both sides projected the most dire outcomes if their ideas were not followed. They both proposed the most extreme negative outcomes if

the other side won. The anti-Federalists predicted despotism, while the Federalists predicted anarchy.

Out of all this we ended up with a marvelous Constitution, and one which very quickly (January 1791) adopted a Bill of Rights.

We also end up with our final two lessons from the process, which are:

- 8. Had there not been a willingness to discuss, differ, argue, and finally to compromise, nothing would have happened and the United States would probably not be the power that it is today.
- 9. The "Founders" stood behind their agreements, even though that involved concession on some of the issues they were most closely bound to.

Early veterans, through their actions, taught the "Founding Fathers" that it was truly possible to throw off foreign domination and to start a nation.

Perhaps it is now our job to teach today's politicians how the nation came to be and how they really need to start acting more like the Founding

Fathers in their deliberations and in their ability to compromise and move forward.

Patrick Henry, inarguably a "Founding Father" and the most adamant of the anti-Federalists, had threatened to withdraw himself from the union if the Constitution were approved. When pressed on the issue he nonetheless said that the preservation of the union was essential, even if it could not be as he would wish it, and that he would support the outcome, if reluctantly

That's compromise of the highest order.

The "Founders", as they actually were, ought to be the model for today's politicians.

It's too bad that they either cannot or will not see that truth, being blinded by their own versions of "truth".

Aren't you tired of not only being taken for granted, but of being taken for a dunce?

I am.[Ed.]

# WARNING TO ALL HANDS

I received a call from a veteran in the Los Angeles Area concerning a company known as "NSA Educational Academy," an organization that is offering assistance for veterans filing VA pensions and aid and assistance claims with the VA. They have been holding seminars in numerous American Legion Posts, so is operating under the guise, this is being and has been approved by the American Legion at Department and National level. This is further form the truth and is not endorsed by the American Legion at either the Department or National Level. By giving this impression a veteran assumed them to be they are legitimate (they may be or not) and endorsed by the American Legion even at the post level. They assisted this veteran in filing and mailing his VA claim, but in return required a fee of \$299 and a signed contract. This veteran reluctantly agreed and made out his check to "Discount Legal Services," which he was instructed to. He later was called and asked for additional fee of roughly \$300 more and told he was contractually obligated to pay. This veteran contacted our office, which in turn we contacted our National Organization and "National Veteran Legal Services Program," affiliated with the American legion in Washington DC and advised the veteran to cut off all contact. The VA Inspector General has been notified and is looking into this, as well as NVLSP.

## LAWMAKERS BLAST NAVY OVER LEJEUNE WATER

WASHINGTON -- Five members of Congress on Friday called the Department of the Navy to task - again - for what they say is an apparent resistance to keeping veterans informed about past water contamination at Camp Lejeune in North Carolina.

In a tartly worded letter to the Navy, Sen. Bill Nelson of Florida, Sens. Kay Hagan and Richard Burr and Rep. Brad Miller of North Carolina, and Rep. John Dingell of Michigan said the military continues to mislead the public about a high-profile scientific report on the contamination. They said that the Navy hasn't yet agreed to a deal that would allow federal scientists to review its public relations material. And, they said, the Navy appears reluctant to lead veterans and their family members to recent, updated science about the contamination.

## NEW BILLS COULD IMPACT MILITARY LIFE

April 18, 2011

Several recently proposed bills could impact important aspects of military life, like military pay, retirement benefits, spouse employment and GI Bill benefits. For example, House bill HR 1297 would ensure military pay is safe in case of future government shutdowns. While Senate bill S.745 would ensure veteran students would not lose GI Bill benefits during scheduled school breaks and HR 1451 would protect current student veterans from the financial impact of GI Bill 2.0. In addition, some FY2012 budget proposals include cuts which could result in TRICARE Prime premium and fee increases, limits on access to the VA health care system for certain vets, and a possible military pay freeze. # **GERMAN FAMILY WANTS GIS TO KNOW ABOUT ESCHENBACH HOSPITAL LAWSUIT**

GRAFENWÖHR, Germany — A recent court victory is leading a German family to look for the parents of American children born at Eschenbach Hospital who might also be victims of dangerous practices by staff and structural negligence between 1987 and 2004.

Two doctors were convicted of gross negligence in medical treatment and a midwife was convicted of assault and illegal use of painkillers in the March 25 verdict. The hospital was found guilty of gross organizational errors.

As an indication of just how many U.S. births there were, the newspaper Der Neue Tag reported that 40 percent of the 10,000 children born between 1968 and 2004 at Eschenbach Hospital were American. The hospital served soldiers and families stationed at Grafenwöhr, Hohenfels and Vilseck as well as surrounding facilities.

## RISING NUMBER OF COALITION TROOP DEATHS COMING AT HANDS OF AFGHAN SECURITY FORCES

The murders on Saturday of five NATO soldiers by a Taliban suicide bomber who enlisted as an Afghan National Army soldier marked the latest in a rising toll of coalition troop deaths at the hands of Afghan security forces they are attempting to train.

Since January, 13 troops with the International Security Assistance Force have been killed when Afghan police, soldiers or security guards — or insurgents who infiltrated their ranks — attacked coalition forces. These types of killings have accounted for the deaths of at least 38 coalition personnel since 2009, according to a Stars and Stripes review, constituting roughly 3 percent of the hostile fire deaths among troops during that time.

By comparison, 27 troops were killed by mortar or indirect fire attacks launched by insurgents during that same time period, according to the independent website icasualties.org.

Surprisingly, the killers are not usually Taliban sleeper agents or impostors. ## SMITH & WESSON PUTTING VETERANS BACK TO WORK

Since last year Air Force Veteran John Jasinski has been without work. "It's tough out there, to go to a place to apply. So many times you see you could be one of a thousand sometimes," Jasinski said.

But next week all of that will change. "It's really just a great opportunity as a new career, that's what I'm seeing it as," Jasinski said.

Jasinksi and more than 10 other veterans graduated Thursday from Mobile Outreach Skills Training ,or MOST, at Smith & Wesson. The program aims to give veterans a new career in manufacturing.

"We take people who have little or no background in the process and we have a fast track training program that allows them to gather and learn a lot of material in a short period of time," Ted Bauer of Mass. Workforce Development said.

Over the course of two weeks the veterans learned all the skills they need to get a jump start at Smith & Wesson. For many veterans the transition from being in the military to being a civilian can be a challenge. Workforce development officials say a veteran's skills are a perfect fit for the private sector.

"The military training brings to them some discipline, however this particular skill is very special and they have the discipline and wherewithal to very quickly adapt and adjust," Bauer said.

#### NORTHROP GRUMMAN FOUNDATION DONATES \$5 MILLION TO USO WOUNDED WARRIORS OPERATION ENDURING CARE INITIATIVE

Arlington, VA. (April 11, 2011) – The Northrop Grumman Foundation is donating \$5 million as the lead donor for the new Wounded Warrior and Family Center on the grounds of Fort Belvoir in Virginia. This is the largest single gift to the USO in the 70-year history of the organization.

The new center will support wounded warriors at the Fort Belvoir Community Hospital and the Warrior Transition Unit. During the transition from inpatient to outpatient care, which can take months, even years, the center will provide wounded troops and their families with tangible and intangible support. Families will have access to a setting that offers relief and understanding amid the rigors of rehabilitation and reintegration as well as the practical elements of day-to-day living, a bastion of comfort on the march out of disability. The center at Fort Belvoir will be a high-end, 25,000 square foot facility where wounded troops and their families can find respite and renewal in "home away from home" surroundings. The center will be operated by the USO of Metropolitan Washington.

# IMPRESSIVE RESULTS: MEDICAL COMMUNITY SHOULD PAY ATTENTION TO VA'S WORK FIGHTING INFECTIONS

Over the past few years, Veterans Affairs hospitals across the country have taken an aggressive approach to combating potentially deadly infections. As The New York Times reported Wednesday, when patients come in, they are screened for infection. Those who test positive for the notorious methicillin-resistant Staphylococcus aureus, or MRSA, bacterium, which is difficult to treat, are isolated. Anyone working with those patients is required to wear gloves and gowns, and other precautions are taken.

A study of 153 VA hospitals, published last week in The New England Journal of Medicine, showed the effort was paying off — there was a 62 percent drop in the rate of MRSA infections in the hospitals' intensive care units over a 32-month period. Other areas of the hospitals showed a 45 percent drop during the same period.

# \$80B PER YEAR FOR MILITARY R&D AND THIS IS WHAT WE GET?

#### JIEDDO: THE MANHATTAN PROJECT THAT BOMBED

As the invasion of Iraq turned into an occupation, a new and deadly threat to U.S. troops emerged, one for which the U.S. was ill prepared: the roadside bomb.

So in February 2006, with casualties mounting, the Pentagon responded by creating a new agency designed to attack the problem by harnessing the full might of America's technology community. The new organization was dubbed the Joint Improvised Explosive Device Defeat Organization, or JIEDDO, and a retired four-star general was tasked to run it.

The launch of JIEDDO eventually turned what had been a 12-person Army anti-homemade bomb task force into a 1,900 person behemoth with nearly \$21 billion to spend.

Yet after five years of work, hundreds of projects, and a blizzard of cash paid to some of America's biggest defense contractors, JIEDDO has not found a high-tech way to detect or defeat these so-called Improvised Explosive Devices (IEDs) from a safe distance. #### **RIFLE-STOPPING HELMET FAILS TESTS**

The top general at Marine Corps Systems Command told lawmakers March 17 that a new combat helmet designed to stop some high-caliber rifle rounds failed to meet specifications during recent ballistic tests.

Brigadier Gen. # DATA SPUR CHANGES IN VA CARE

Hospitals serving U.S. military veterans are moving fast to improve care after the government opened a trove of performance data—including surgical death rates—to the public. The U.S. Department of Veterans Affairs in November started posting online comparisons of the nation's 152 VA hospitals based on patient outcomes: essentially, how likely patients are to survive a visit without complications at one hospital compared with the rest. This unusually comprehensive sort of consumer information on medical outcomes remains largely hidden from the tens of millions of Americans outside the VA system, including many of those in the federal Medicare system.

#### WE NEED A CLOSER LOOK AT WOMEN VETS' UNIQUE PROBLEMS

#### FEMALE VETERAN FIGHTS AN INVISIBLE INJURY

Angel Harris returned from Afghanistan eight years ago pregnant and — like thousands of other female veterans — with a case of PTSD, a disorder that took six years to diagnose. The military has only recently begun to offer women the same PTSD benefits as men.

The Bullfrog Brewery is crowded for lunch and tables are scarce, but former Army Sgt. Angel Harris finds one where she can sit with her back to a wall and still see out a window. She isn't sure what she's watching for. A sniper maybe, or an ambush.

This is downtown Williamsport — the Appalachian hamlet where Little League was born — not the sort of place where people wait around for something awful to happen. But that's the way Harris has viewed the world since she returned from Afghanistan eight years ago carrying her unborn son and a case of PTSD.

The baby was easy to figure out. A home pregnancy test administered in a camp latrine saw to that. The post-traumatic stress disorder took more than six years to diagnose. Women are not permitted to serve in direct ground combat in the U.S. armed forces, so by military reasoning, they weren't likely to suffer from combat-related trauma. GIVING FEMALE VETERANS A CHANCE TO SHARE THEIR PAIN

The war veterans gathered amid the tranquil gardens and arched walkways of the Mission San Luis Rey in Oceanside. In a circle, they sat together, more than 50 women in all. Some laughed and chatted as they settled in chairs or propped themselves up on the floor of an adobe-walled hall. Others glanced around, uncertain what to expect from a weekend retreat. Several commented that it was the first time they had been in a room with so many women.

"I feel like I'm in a Lamaze group," Kristine Wise, a 41-year-old former soldier from Oceanside, said with a chuckle.

For years, the women concealed their femininity beneath tough military garb. # THERE'S NO QUICK FIX FOR VETERANS

It has been nearly five years since I left the Army and still my time in the service is fresh in my mind. I think about my deployments every single day without fail. I have friends and family, responsibilities and passions that keep me moving, but the time I spent in the Army and in Iraq are what continue to define me.

Many current and former service members feel the same way. The act of participating in war casts a shadow over everything else in life. Facing high stress and danger for so long makes it tremendously difficult to leave the military and rejoin civilian society. Day-to-day concerns seem trivial compared to the life or death urgency of military situations. When I first came home, I would become furious at how easily everyone in this country can carry on virtually ignoring the fact that we are at war.

I worked as a server as I used my GI Bill benefits to earn a bachelor's degree in English Communication, but after graduating with honors, I could not find a job in my field. After a year of looking for meaningful employment, I enrolled in graduate school largely out of fear that my degree would become obsolete before I could even get a shot at any real work experience. The fact that women veterans are among the highest unemployed populations leaves me with questions about whether my service is continuing to hurt me in ways I cannot even see.

I've struggled with processing my experiences as a woman in the military. Five years later, I am just beginning to seek help for Military Sexual Trauma (MST), a rape that I could not admit to myself let alone report to authorities. My acquiescence and perpetuation of victim blaming, so rampant in the military, kept me in denial about what I had suffered. # **INSTEAD OF HELPING, TRUSTEE PROGRAM IS HURTING VETERANS, FAMILIES SAY**

LANCASTER, Tex. — During the Korean War, Billy Brown faced enemy bullets, starvation and bitter cold. Now the benefits that he earned for his sacrifice have been tied up by the Department of Veterans Affairs, which in 2009 diverted his payments to trustees who have taken control not only of those funds, but of his life savings of some \$100,000 as well.

Richard Wortham, Mr. Brown's son, gained power of attorney for his father four years before the department stepped in, and found out about his father's new financial minder only when he tried to withdraw money from the bank. "They said we no longer had access to his money — we could only get it from the fiduciary," Mr. Wortham said.

# **REPORT: VET ON DEATH BED EJECTED BY VA**

HAMPTON -- The Hampton VA Medical Center inappropriately discharged a terminally ill veteran from its emergency room and failed to provide him hospice care requested by his wife, a federal investigation has found.

Investigators from the U.S. Department of Veterans Affairs' Office of Inspector General found that staff members at the Hampton center were unaware of a VA policy requiring that end-of-life care be provided when veterans and their families ask for it. The investigators' report, issued Wednesday, came in response to a confidential complaint about the treatment of the veteran, a man in his 50s, who came to the center in August ill with lung cancer that had spread to the brain.

Over three successive visits to the emergency room, the man's condition steadily deteriorated. By the third visit, he was weak, confused, incontinent and required help from VA staff to get out of his car.

His wife told the staff she was having difficulty managing him and could no longer care for him at home.

Nevertheless, the emergency room doctor discharged him, saying he did not meet the hospital's criteria for acute-care admission. #### **BUDGET PANEL EYES END TO VA CARE FOR 1.3 MILLION VETS**

The House Budget Committee, chaired by Rep. Paul Ryan (R-Wis.), has told a veterans' group it is studying a plan to save \$6 billion annually in VA health care costs by cancelling enrollment of any veteran who doesn't have a service-related medical condition and is not poor.

Committee Republicans, searching for ways to curb federal deficits and rein in galloping VA costs, are targeting 1.3 million veterans who claim priority group 7 or 8 status and have access to VA care.

Priority group 8 veterans have no service-connected disabilities and annual incomes, or net worth, that exceed VA means-test thresholds and VA "geographic income" thresholds, which are set by family size.

Priority Group 7 veterans also have no service-connected disabilities and their incomes are above the means-test thresholds. But their incomes or net worth fall below the geographic index. 
## **BACKLOG BURIES VETERANS' CLAIMS**

WASHINGTON — The number of veterans' disability claims taking more than four months to complete has doubled, prompting criticism from veterans and Congress that the Department of Veterans Affairs failed to prepare for a rise in cases it knew was coming.

"Without question, I believe that the VA disability claims system is broken," Sen. Patty Murray, D-Wash., chairwoman of the Senate Veterans Affairs Committee, said Wednesday.

The number of claims that take more than 125 days to decide has gone from 200,000 a year ago to 450,000 today, according to administration budget documents. As a result, veterans must wait even longer to receive payments for disabilities.



# HALF THE AFGHANISTAN AND IRAQ VETERANS TREATED BY VA RECEIVE MENTAL HEALTH CARE

Slightly more than half of all Afghanistan and Iraq war veterans treated by the Veterans Affairs Department received care for mental health problems, roughly four times the rate of the general population, according to statistics compiled by the advocacy group Veterans for Common Sense based on data obtained under the Freedom of Information Act. #### AFTERSHOCK: THE TICKING TIME BOMB OF SOLDIERS' TRAUMATIC BRAIN INJURIES

MINOT, ND -- At 8:20 p.m. on Sept. 21, 2010, Iraq veteran Brock Savelkoul decided it was time to die. He lurched from his black Tacoma pickup truck, gripping a 9-mm pistol. In front of him, a half dozen law enforcement officers crouched behind patrol cars with their weapons drawn. They had surrounded him on a muddy red road after an hour-long chase that reached speeds of 105 miles per hour. Savelkoul stared at the ring of men and women before ducking into the cab of his truck. He cranked up the radio. A country song about whiskey and cigarettes wafted out across an endless sprawl of North Dakota farmland, stubbled from the recent harvest. Sleet was falling, chilling the air. Savelkoul, 29, walked slowly toward the officers. He gestured wildly with his gun. "Go ahead, shoot me! ... Please, shoot me," he yelled, his face illuminated in a chiaroscuro of blazing spotlights and the deepening darkness. "Do it. Pull it. Do I have to point my gun at you to ... do it?"

## THE PENTAGON'S ACHILLES' HEEL

The Pentagon currently spends more than \$50 billion — about 10% of its base budget — on healthcare, an almost 300% increase over the last decade. ## THE MILITARY'S SECRET SHAME

When men in the military rape other men in the ranks, no one wants to talk about it. Why the sexual assault of males in the service is finally being confronted.

Greg Jeloudov was 35 and new to America when he decided to join the Army. Like most soldiers, he was driven by both patriotism for his adopted homeland and the pragmatic notion that the military could be a first step in a career that would enable him to provide for his new family. Instead, Jeloudov arrived at Fort Benning, Ga., for basic training in May 2009, in the middle of the economic crisis and rising xenophobia. The soldiers in his unit, responding to his Russian accent and New York City address, called him a "champagne socialist" and a "commie faggot." He was, he told NEWSWEEK, "in the middle of the viper's pit." Less than two weeks after arriving on base, he was gang-raped in the barracks by men who said they were showing him who was in charge of the United States. When he reported the attack to unit commanders, he says they told him, "It must have been your fault. You must have provoked them."

At times, he served on the front lines treating infections. #### TRICARE YOUNG ADULT PROGRAM: COMING SOON

March 30, 2011 No. 11-19

FALLS CHURCH, Va – Qualified TRICARE dependents up to age 26 can soon purchase TRICARE coverage on a month-tomonth basis. To qualify to purchase TRICARE Young Adult (TYA) coverage, dependents must be under 26, unmarried and not eligible for their own employer-sponsor health coverage.

TYA will initially offer a premium-based TRICARE Standard benefit with a premium-based TRICARE Prime benefit phased in later this year. Eligible family members who receive health care services between Jan. 1, 2011 and when the program is implemented can purchase TYA coverage retroactively to Jan. 1, 2011. Beneficiaries should save their receipts.

Premium costs will be announced prior to start of enrollment later this spring. Once premiums are determined, TYA-eligible beneficiaries should explore all of their health care coverage options to choose a plan that makes sense for them. #### NATIONAL GUARD AND RESERVE ACTIVATED AS OF MARCH 15, 2011

At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 67,595; Navy Reserve, 5,921; Air National Guard and Air Force Reserve, 9,589; Marine Corps Reserve, 5,110, and the Coast Guard Reserve, 797. This brings the total National Guard and Reserve personnel who have been activated to 89,012, including both units and individual augmentees. #### HEROIC BOMB, ATTACK DOG 'VALDO' SAVES 4 COALITION LIVES

HERAT, Afghanistan – Petty Officer 1st Class Valdo is a Navy military working dog and he's trained to smell explosives. Though Valdo is a veteran at bomb and improvised explosive device detection, the 7-year-old patrol dog's abilities were tested on an April 3 combat foot patrol north of the Bala Murghab security bubble in Badghis province, Afghanistan.

Red Platoon, Bulldog Troop, 7th Squadron, 10th Cavalry Regiment scouts from Fort Carson, Colo., ventured further than coalition forces ever had before on the mission, and plotted fighting positions, and to anticipate possible enemy location. Valdo's role was to smell out mines, IEDs or booby traps. He served honorably.

... Red Platoon came under a sustained attack the following morning, and Valdo was injured by a rocket propelled grenade, which breached Red Platoon's fighting position and landed directly behind him. Valdo was seriously injured in the blast. #### NO MORE SSNS ON DEFENSE ID CARDS

When the current crop of Defense Department ID cards start to expire this June, they will be replaced with new ones that no longer contain a Social Security number as an identifier.

Air Force Maj. Monica Matoush, a Pentagon spokeswoman, said the SSN will be replaced by a new, unique 10-digit Defense ID number, and this shift will help reduce identity theft.

This is a real back-to-the-future concept as both my father, a veteran of The Big One, and I, when I served in the Marine Corps in the 1960s, had serial numbers, not Social Security numbers, as identifiers.

The paper added that local commanders have the freedom to impose harsher bans at their discretion.

#### DEADLINE FOR RETROACTIVE STOP LOSS SPECIAL PAY EXTENDED ~ AGAIN April 20, 2011

The deadline for eligible service members, veterans and their beneficiaries to apply for Retroactive Stop Loss Special Pay (RSLSP) has been extended to Oct. 21, 2011, allowing those eligible more time to apply for the benefits they've earned under the program guidelines.

The deadline extension is included in Continuing Resolution H.R. 1473, signed by President Obama April 15, 2011, providing funding for federal government operations through Oct. 21, 2011.

The RSLSP was established to compensate for the hardships military members encountered when their service was involuntarily extended under Stop Loss Authority between Sept. 11, 2001, and Sept. 30, 2009. Eligible members or their beneficiaries may submit a claim to their respective military service in order to receive the benefit of \$500 for each full or partial month served in a Stop Loss status.

When RSLSP began on Oct. 21, 2009, the services estimated 145,000 service members, veterans and beneficiaries were eligible for this benefit. Because the majority of those eligible had separated from the military, the services have engaged in extensive and persistent outreach efforts over the past 18 months. Outreach efforts including direct mail and engaging military and veteran service organizations, social networks and media outlets, will continue through Oct. 21, 2011.
