## FIRST CALL – NOTES FROM THE FRONT

### THE SMELL OF MENDACITY

I was recently re-reading a book from our reading list: *Dereliction of Duty*, by then-Major H. R. McMaster\*, published in 1997. The subtitle tells the tale – “Lyndon Johnson, Robert McNamara, the Joint Chiefs of Staff, and the Lies That Led to Vietnam.”

*\* The book was McMaster’s PhD thesis at the University of North Carolina at Chapel Hill. McMaster was promoted to Brigadier General in 2009.*

As with the first reading, I really got worked up over the lies that were promulgated to justify the expansion of the Vietnam War, and about the politics that ruled Lyndon Johnson’s decisions about the war. My anger drove me to re-read Bernard Fall’s *Street Without Joy*, the story of the French defeat and the US’s initial involvement, and then Neal Sheehan’s *A Bright Shining Lie*, the story of John Paul Vann.

By the time I was finished I was bordering on apoplexy. Nothing was new – I had read all about it before – but the re-reading brought my blood to a boil once again.

This time, however, I had a new point of reference. If I merely replaced the word “Vietnam” with “Iraq” or “Afghanistan”, and the words “jungle and swamp” with “desert and mountains”, and “Viet Minh” and “Viet Cong” with “Taliban” and “Al Qaida”, all of the lies leading up to and during Vietnam could have served the current conflicts pretty well.

Why is it that the truth is never enough? What is it that infects our political and military leadership when they reach high office that compels them to mendacity and hypocrisy?

Why do they hold the American people and particularly the serving military in such contempt that they cannot tell us the truth? Mendacity!

Why do they say they will do one thing when they know that they mean to do something altogether different or more often nothing at all? Hypocrisy!

*“Hypocrisy can afford to be magnificent in its promises, for never intending to go beyond promise, it costs nothing.”~ Edmund Burke*

How can we retain faith in such a system, and in such “leaders”?

If we cannot trust them to tell us the truth about the war, how can we trust them on any other issue?

If we cannot trust them to do what they say about the military and their families and those veterans who served before, how can we trust them to deal fairly with all citizens on any issue?

The Constitution doesn’t say “We the People and Them the Leaders”, as if “the People” were somehow a lackey class subservient to a separate leadership class.

That’s pretty much what we believe the American Revolution was fought over, isn’t it? No one should have the right or the power to lie to us, to lead us astray, or to use us to serve their private need for power, wealth or position.

The leaders are not there by right of birth or wealth. They are supposed to be there because we chose them to represent us, not to represent their personal position or their future employment.

Please don’t misunderstand! I am not referring to any one party or faction. They all do it. They will tell us what they want us to know, whether or not it is true, regardless of their party.

For every “Tonkin Gulf”, there is a “WMD”. For every “Light at the End of the Tunnel”, there is a “Mission Accomplished.”

One side screams that black is white: the other side screams that white is black. (There are no shades of gray). The result is that we know that they both are lying to some extent so we turn off.

We give up demanding that they tell us the truth. We stop demanding that they perform. We have come to know that we cannot make a difference so we just retire from the fray.

And that is just what they want.

Both sides shout that they will take care of veterans. One side says they can only do it by doing A, B, and C. The other side says that A, B, and C will fail so they will do X, Y, and Z. Neither does much of anything but they don't have to because they already got your vote.

Eight years and four months into the Afghan War, and one month shy of seven years into the Iraq War and hundreds of thousands of veterans are waiting for DVA decisions. Tens of thousands of serving military are going back for fourth – fifth – even sixth tours without relief.

Families are taking up the slack where the services and the DVA have failed, and those agencies are making their budgets on not providing service either to veterans or to the families that are providing home care for profoundly injured and mentally damaged returnees.

Why should veterans get all of those extra services they were promised? Everybody's hurting. Aren't veterans just another “interest group”? Hardly!

Recently, after promising all sorts of things to veterans in order to get their votes – almost every one of them did it – our Congress can't come up with \$55M to provide real help to families who are taking care of wounded veterans. Senate bill S 1963 which would provide those funds has sat in the House Veterans Affairs Committee for three months and as yet is not scheduled for a hearing.

All that in the same month Congress fought to kill healthcare reform for all Americans unless it included hundreds of millions of dollars of safety nets and breaks for commercial insurance companies, and they bent over backwards to send hundreds of millions to Haiti.

Don't misunderstand. I am glad that we are helping out in Haiti. That is what a world leader ought to do.

But national leaders incur an obligation when they take that oath. That obligation is to be truthful; to work at all times for the betterment of all of the American people and of the United States in the world; and to take care of those who give extra for our nation's goals and policies.

Military and veterans and their families do give extra – they may be the only ones left who do. They may be the only ones who still believe that a nation is founded in its people, and that the people have the right to make demands on their leadership or to replace them. [No I am not a “Tea-partier” – I believe that change comes through the ballot box; I don't hate “big government”; nor do I regret paying my taxes.]

The military may be the only ones who retain a true American sense of community with all Americans because they step forward to defend them every day. As we fight or have fought for their safety, we should be fighting today for their rights and their freedoms.

The oath that our military and political leaders take has come to mean, apparently, that they are bound only to those who pay for their campaigns, or who have the power over their promotions. They can tell us anything that either promotes or protects their well-being and their future possibilities. As Neal Sheehan reports, “We were [forced] to come to grips with a constant disparity between our perception of reality and higher authority's version of it.”

Your Representative represents about 650,000 people. How come a lobbyist representing that newly identified corporate “person” from some other state, and certainly from some other district, can get your representative to return his or her phone calls, and can easily get face time with your representative, and you can't get anything from him or her but a computer-generated response?

Is that representation? Well I guess it is, of a sort, but it certainly doesn't seem to be listed in my copy of the Constitution.

They all support the policies that injure and kill our fighting men and women, they just don't support the aftermath. It's too expensive and apparently inconvenient.

But that doesn't stop them from promising the world, does it? Hypocrisy! Mendacity!

Well it stinks. I wonder if it will ever change? We cannot go back - it has almost always been this way.

We must go forward. Why can't 24 million veterans work together to start to put things right?

If we were a "voting bloc" things would change. If we could work together and tell ourselves and others the truth – not the truth as we believe it to be ideologically, but the truth that is borne out in facts and experience – we could change our world, and by doing so benefit not only veterans but also all Americans.

Pardon me for my naiveté but I will not give up on change for the better. I will not give up on trying to make those whom we have served to serve us instead of serving themselves.

I saw a newborn the other day and I thought that when I was that age – several months – someone my age – 75 – had been born in the first year of the American Civil War.

I have lived through or have known others who have lived through 150 years of our history, most of it marked by wars. They suffered from the same hypocrisy and heard the same lies that today's soldiers are hearing.

It is well past time to end the hypocrisy and the mendacity.

It poisons the soul of the nation.

**MORRISON & FOERSTER SECURES VICTORY FOR TROOPS EXPOSED TO CHEMICAL AND BIOLOGICAL WEAPONS TESTING IN CASE AGAINST THE U.S. GOVERNMENT**

January 22, 2010

SAN FRANCISCO (January 20, 2010) – Morrison & Foerster yesterday won the right to proceed with a case against the CIA, the Department of Defense, and the U.S. Army, filed on behalf of veterans rights organizations Vietnam Veterans of America and Swords to Plowshares, along with six veterans with multiple diseases and ailments, tied to a secret testing program in which U.S. military personnel were deliberately exposed to chemical and biological weapons and other toxins without informed consent. Plaintiffs seek declaratory and injunctive relief that would free them from their secrecy oaths and grant them healthcare that they were promised.

On January 19, 2010, Judge Claudia Wilken of the U.S. District Court, Northern District of California, issued an order that overruled the government's main arguments to dismiss the case, which were based upon lack of jurisdiction, failure to state a claim for relief, statute of limitations, sovereign immunity, and standing. <More at: <http://mofo.com/news/pressreleases/16406.html>>

**VETERANS' AFFAIRS COMMITTEE APPROVES BILLS AIMED AT MILITARY EXPOSURES, HOMELESSNESS AND HEALTH CARE**

Chairman Akaka's military exposure legislation would provide care for individuals exposed to environmental hazards at Camp Lejeune and Atsugi Naval Air Facility, and set up a national response for other potential military installation exposures.

### **U.S. MILITARY FAULTS LEADERS IN ATTACK ON BASE**

KABUL, Afghanistan — The United States military issued its long-awaited report Friday on how insurgents managed to overrun an American combat outpost in eastern Afghanistan in October and kill eight soldiers in the worst single ground attack in the last year and a half.

The report's findings are damning. Combat Outpost Keating in Nuristan Province had "no tactical or strategic value," the report said. It was overdue to be closed, and measures to protect it were lax, even though it had been attacked 47 times in the preceding five months. Intelligence reports of a major attack went unheeded.

#### **TROOPS: STRICT WAR RULES SLOW AFGHAN OFFENSIVE**

MARJAH, Afghanistan (AP) -- Some American and Afghan troops say they're fighting the latest offensive in Afghanistan with a handicap - strict rules that routinely force them to hold their fire.

Although details of the new guidelines are classified to keep insurgents from reading them, U.S. troops say the Taliban are keenly aware of the restrictions.

"I understand the reason behind it, but it's so hard to fight a war like this," said Lance Cpl. Travis Anderson, 20, of Altoona, Iowa. #### **GEN. PETRAEUS SAYS WAR IN AFGHANISTAN WILL GET 'TOUGHER BEFORE IT GETS EASIER'**

For David Petraeus, complicated missions such as fighting a counterinsurgency war or developing strife-torn nations start with three core principles: First, get the "big idea" clear in your head; next, communicate how that will be put into action; and, finally, get to work. Petraeus, the Army general who has led the country's Central Command since October 2008, says the war in Afghanistan has reached the third stage.

Speaking yesterday to the World Affairs Council of Philadelphia, Petraeus said the military now has the infrastructure and personnel in Afghanistan to turn the tide against the Taliban and al Qaeda. He compared the surge of troops approved by President Obama in December for that mission to a 2007 surge for Iraq approved by President Bush.

The violence intensified in Iraq with the surge before that country started to stabilize, he said.

"It is hard and it is hard every day," Petraeus said of the effort in Afghanistan, "and it's going to be tougher before it gets easier." <More at:

## **GERMAN CABINET OKAYS AFGHAN TROOP BOOST**

Government spokesman Christoph Steegmans said Tuesday that the mandate under which German soldiers serve in Afghanistan will be raised to allow a maximum 5,350 to serve there - up from the current 4,500.

## **SURVEY OF MILITARY FINDS MORE ACCEPTANCE OF GAYS**

In the most comprehensive survey yet on service members' attitudes about gays in the military, slightly more than 3,000 Military Times readers contacted randomly by e-mail and through flyers placed in random newsstand copies late last fall offer a clear glimpse of attitudes and experiences in today's military.

The majority of troops are generally happy with the current policy -- but opposition to a change is dropping steadily.

The percentage of respondents who oppose repealing the Don't Ask, Don't Tell policy fell to just 51%, a decline of 12 percentage points since 2003. The percentage favoring repeal, meanwhile, rose during the same period by 6 points, to 30% among active-duty readers of Army Times, Air Force Times, Navy Times and Marine Corps Times.

## **NEW COALITION VOWS FIGHT ON “DON’T ASK, DON’T TELL” REPEAL**

#### **PROMISES, PROMISES: WAR WIDOWS' FUTILE FIGHT**

WASHINGTON (AP) -- For a decade, war widows in matching yellow suit jackets and hats quietly and persistently have knocked on Capitol Hill doors seeking an end to the "widows' tax," a government policy that deprives them of benefits from their husbands' military service.

They are always warmly received, but that's where the hospitality ends. Despite pledges of help from scores of federal officials -- including President Barack Obama and House Speaker Nancy Pelosi -- their long quest remains unfulfilled.

Every year since 2005, the Senate has voted to eliminate the policy that denies widows the ability to collect both a military survivor's benefit and the full annuity bought when their military husbands were alive. But in each of those years, the fix was dropped when House and Senate negotiators wrote the final bill in private.

## **BENEFIT UPGRADE FOR MILITARY VETERANS WITH PTSD**

More than 4,300 Iraq and Afghanistan war veterans who were diagnosed while still in service as suffering from post-traumatic stress disorder, but got low military disability ratings, have won an agreement to upgrade them retroactively to 50 percent.

The higher rating will represent an important win for this group of veterans mentally scarred by war. It will mean, from date of discharge, eligibility for disability retirement and access to Tricare, the military's triple health insurance option, for the veterans, spouses and dependent children. Any out-of-pocket medical costs since discharge also could be paid retroactively, and these soon-to-be-designated disabled retirees will gain access to discounted shopping and recreational services on base.

Kevin Kammerdiener's mother, Leslie, takes care of his every need, which would be fine if he were in preschool.

The thing is, "Kamm" is 21. He suffered a traumatic brain injury, shattered bones and burns on 25% of his body in Afghanistan in May 2008, which left him in a wheelchair, unable to speak and in chronic pain.

Leslie moved from Pennsylvania to her son's home in Riverview, Fla., to care for him after he spent months at a military hospital in San Antonio.

Now Leslie Kammerdiener, 44, spends her days making sure Kevin eats well, is clean and comfortable, and is not in pain.

... "I'm lucky if I get two to four hours of sleep at one time," Kammerdiener says.

## **COMBAT INJURIES NOT THE LEADING REASON US SOLDIERS ARE EVACUATED**

LONDON (AP) — American soldiers in Iraq and Afghanistan were more likely to be medically evacuated for health problems such as a bad back than for combat injuries, a new study says. Researchers also found psychiatric disorders rose during the period studied — 2004 to 2007 — despite an increased focus on treating mental health problems. The research was published Friday in the British medical journal, Lancet.

### **VETERANS SPEAK OUT AGAINST BURN PITS**

The noxious smoke plumes that wafted over the military base in Balad, Iraq, alarmed Lt. Col. Michelle Franco. The stench from a huge burn pit clung to her clothing, skin and hair.

"I remember thinking: This doesn't look good, smell good or taste good," Franco said recently. "I knew it couldn't be good for anybody."

She wheezed and coughed constantly. When Franco returned to the U.S., she was diagnosed with reactive airway dysfunction syndrome. She is no longer able to serve as an Air Force nurse.

### **REPORT ON VIRGINIA VA CENTER FINDS PROBLEMS**

A new report from the Veterans Affairs Department inspector general will help fuel complaints about an error-filled disability claims process in need of a complete overhaul.

Investigators looking at claims processing at the VA regional office in Roanoke, Va., found that 25 percent of the case files they closely studied had serious mistakes. Some veterans were denied benefits they deserved, and disability compensation was given to others who were not eligible. Many errors involved Vietnam veterans with disability claims related to exposure to the defoliant Agent Orange.

In one case, a veteran was underpaid \$21,857 because the claims staff did not properly consider a physician's opinion that coronary artery disease was a complication of service-connected diabetes. In another, a veteran was overpaid \$15,640 for a diabetes-related amputation below the knee that he said was related to exposure to Agent Orange in Vietnam. His claims folder contained no evidence that he had served in Vietnam, the IG report says.

Why veterans deserve special courts.

The problem is hardly a new one, but we need only watch *The Hurt Locker* to refresh our collective memory: veterans return from war, having seen and survived unspeakable things, then try to adjust to civilian life with inadequate resources and support. Depending on the study you read, between 20 and 50 percent of veterans from the Iraq and Afghanistan wars suffer from posttraumatic stress and other mental disorders—and half don't seek mental-health care. Those who do don't always receive the kind of care they need. The results of these systemic failures are increased instances of rape, assault, addiction, and other criminal acts that tangle up veterans in the criminal courts. ## **CAMP LEJEUNE'S EX-RESIDENTS, MANY ILL, ONLY NOW LEARNING OF TOXIC WATER**

WASHINGTON — Paul Akers was in his oncologist's office last summer when his adult daughter handed him a magazine.

He saw a half-page ad from the Marine Corps, alerting former residents of Camp Lejeune, N.C., that if they lived on the base between 1957 and 1987, they might have been exposed to contaminated water.

Akers thought about his mother, the wife of a Marine, who died in 1960. He remembered his little sister, whom he called Penny. She died of cancer in June at 61. She'd been diagnosed last spring, when she went in to be tested as a bone marrow match for her ailing brother. She was dead within a month. Akers thought, too, of his own struggle, undergoing chemotherapy for non-Hodgkin's lymphoma.

"You can see why I'm angry at the military," Akers told McClatchy Newspapers.

Akers, 64, lived on base for years as a young child, building forts among the pine trees and splashing in a plastic kiddie pool with his little sister, cooling off in the sweltering Carolina summers. The water, it turned out, was poisonous.

Although that was discovered a quarter-century ago, neither Akers nor his sister had known that residents of Camp Lejeune drank contaminated well water for decades. The Marines have registered thousands of people across the country who say they've been plagued by illnesses related to the toxic water, but the Department of the Navy, which includes the Marine Corps, still refuses to pay for a \$1.6 million study into the deaths of former residents of Camp Lejeune.

Public questions about the quality of mental health care provided by a private contractor at the base were raised last year by the September firing of Dr. Kernan Manion, a brain trauma specialist who had complained to commanders about poor facilities, inadequate care programs and weak security.

Walter Jones, a Republican whose district includes Camp Lejeune, asked Defense Secretary Robert Gates for a probe of the mental health care issue after Salon.com, which first reported Manion's firing, last week reported on documents it obtained that showed officials had changed Manion's job performance evaluations from good to bad after his complaints.

## EUCOM PENS 'BILL OF RIGHTS' FOR MENTAL HEALTH PATIENTS

STUTT GART, Germany — A plan that calls for combining mental health care clinics and primary care clinics to reduce the stigma of seeking help for psychological problems has been approved by U.S. European Command's top leaders.

The Veterans Affairs Department has set strict guidelines for bidding on contracts set-aside for veteran-owned small businesses. Entrepreneurs will be allowed only one company at a time in the contracting program and must work full time in the business, according to a final rule published on Monday in the *Federal Register*.

WASHINGTON—Following an order issued by the judge overseeing *Sabo v. United States*, legal notices are being mailed this week to more than 4,300 veterans who served in Operation Iraqi Freedom or Operation Enduring Freedom and were diagnosed with post traumatic stress disorder (PTSD).

The court's notice invites them to join a class action lawsuit filed in December 2008 in the U.S. Court of Federal Claims by signing and submitting an "opt-in" form no later than July 24, 2010. Submitting this form will allow these veterans to take advantage of a negotiated resolution that guarantees an upgrade in the veteran's disability rating ... Veterans who do not receive the legal notice, but who believe they may qualify as a class member in *Sabo vs. United States*, should go to [www.ptsdlawsuit.com](http://www.ptsdlawsuit.com) to obtain information about their rights in the lawsuit.
