### YOU CAN'T HAVE IT BOTH WAYS!

George Washington said, "When we assumed the Soldier, we did not lay aside the Citizen." But the difference between a professional military and a citizen's army are profound, and each makes its own demands on the nation.

The professional military requires the commitment by the soldier of a significant portion of a lifetime to the study of arms, and to the pursuit, at all costs, of national purpose when arms are called upon to effect that purpose. Having a professional military demands of the taxpayers that they pay for the services – all of them – that their hired professionals require.

The citizens army counts on a small cadre of professionals to maintain the training and leadership base, and requires of all citizens a commitment to some small portion of their lives to service. Through both taxes and through voluntary associations they bear the burden of the survivors.

The suspension of the draft in 1973 defined the armed force pretty much for all time. The American people didn't want a citizens' army – they wanted a professional army, calling it "All-Volunteer" so that it didn't sound so "professional".

All administrations have left much of the long-term help for the wounded and disabled soldiers to volunteers. By doing so they have it both ways. They get the professional army they want, and they don't have to pay the full price. They go so far as to re-direct veterans to voluntary organizations for assistance, instead of expanding the formal organizations such as the VA to handle the cost. They short-change the formal organizations, and appeal to the patriotism of the citizenry to support the veterans. Instead of buying the wheelchair or the prosthetic, they praise the volunteers who sacrifice to do the government's job, and then take credit for inspiring that volunteerism to cover their own failures.

Those volunteers are disappearing. The large organizations, peopled by WWII, Korea, and Vietnam war veterans are getting smaller and smaller as fewer people join. Smaller, community-based organizations seem to thrive only when local personnel serve: without that local involvement they tend to die out.

As the true citizen army moves further into the past, so also does the willingness of ordinary citizens to volunteer to help the veteran. Citizens who had already served felt a camaraderie for those who also served. Very few citizens serve these days; very few are capable of understanding exactly what price the veteran pays.

Young citizens who were to face the draft grew up considering when and how they would fulfill their commitment, so they and their families were aware of the veteran and the veteran's needs. They too had a good chance of having those same needs.

We need to get things back on track. We need to tell everyone that they cannot have it both ways. If you want a professional force, pay the price. If you don't want to pay the price, restart the draft.

With a professional army, the moment that a soldier takes the oath the government must be committed to continuing care for a lifetime. The professional soldier gives up almost all other possibilities for personal advancement, and most possibilities for personal wealth. They also give up some of their rights as citizens. In exchange they should receive good pay, full medical benefits for life, and a respectable pension.

Maybe we should collect a separate sum from each taxpayer that is their portion of the costs of both war and the maintenance of a professional war-making force. The current war is costing \$250M a day; each taxpayer could receive a separate bill for war expenses of \$300 per family member. The taxpayer could then receive another separate bill for the maintenance of the armed force. At \$481B for 2008 that would be \$1,600 more for each family member as a continuing cost. The bill could be delivered by a disabled veteran.

The services are sending many veterans back into public life with long-term problems, but doing it in such a way that they do not retain responsibility for them. "Let the volunteers take care of it." Or, "Let the VA take care of it." But, the government is under-funding the VA and the volunteers are disappearing. "Oh well. Next problem?"

There are not enough volunteers to handle the problems we are growing daily, and veterans are falling farther behind on the scale of interest of the American people. As an example, at justgive.org, which advertises itself as a gateway to 1,000,000 charities, there isn't even a category for veterans.

It is past time for America to pay the complete price for having the military force it wants.

It is also well past time to decide what sort of foreign policy we will have and what the size, scope and mission of the force called for in that policy is.

But that's another story.[Ed.]

### **CONGRESS SHORT ON MILITARY EXPERIENCE**

As Congress debates the war in Iraq, the Senate and House are short on military experience. Only 29 of 100 senators and 23 percent of House members today have worn a uniform -- the lowest percentages since World War II, a review by Media General News Service found. . . . "The lack of veterans in Congress has resulted in an insensitivity to the burdens placed on troops and their families by the war and frequent deployments," said Steve Strobege, director of government relations for Military Officers Association of America. "One percent of the population is bearing 100 percent of the burden of the war," he said.

### **PACE: NOT ENOUGH EQUIPMENT FOR SURGE**

February 6, 2007

U.S. Marine Gen. Peter Pace admitted to the Senate Armed Services Committee Tuesday equipment will be a problem when U.S. forces in Iraq are increased. During testimony over the \$481.4 billion fiscal 2008 defense budget, Pace said the military has about 41,000 armored vehicles in Iraq -- fewer than will be needed "to cover all of the troops that are deploying." Pace said it will be July before enough equipment is in place.

"The commanders on the ground have talked with the chief of staff of the Army and the commandant of the Marine Corps and have agreed that they will be able to share the assets on the ground so that no soldier or Marine will leave the compound without proper protection," Pace said when asked why more troops should be deployed immediately. **HOT-BEDDING AS POLICY?**

### **U.S. TROOPS STILL SHORT ON GEAR**

WASHINGTON - Hundreds of U.S. troops in Iraq and Afghanistan have experienced shortages of key protective equipment including armored vehicles, roadside-bomb countermeasures and communications gear, a Pentagon survey released Tuesday shows. The Defense Department Inspector General's Office polled roughly 1,100 service members and found they weren't always adequately equipped for their missions. The troops were interviewed in Iraq and Afghanistan last May and June.

### **MOBILIZATIONS - ROUND TWO**

Hundreds of thousands of National Guard and Reserve members previously mobilized for tours in Iraq and Afghanistan are exposed anew to involuntary call-up under a policy change unveiled with President Bush's plan to "surge" forces into Baghdad. Defense Secretary Robert Gates said he has rescinded a rule, set in 2002, that barred involuntary mobilization of reserve personnel beyond a "cumulative" 24-month ceiling for a wartime emergency. But Gates also softened the effect of that decision by capping future involuntary mobilizations at 12 months apiece, including training time. This replaces what has been routine 16-to-24-month mobilizations for most Guard or Reserve members including a year "boots on the ground" in Iraq or Afghanistan. The now shelved 24-month "cumulative" rule had been in effect five years, long enough that some Guard and Reserve members, and their families, might have believed it protected against a second call-up. ### **SOLDIERS IN IRAQ VIEW TROOP SURGE AS A LOST CAUSE**

BAGHDAD, Iraq - Army 1st Lt. Antonio Hardy took a slow look around the east Baghdad neighborhood that he and his men were patrolling. He grimaced at the sound of gunshots in the distance. A machine gunner on top of a Humvee scanned the rooftops for snipers. Some of Hardy's men wondered aloud if they'd get hit by a roadside bomb on the way back to their base.

"To be honest, it's going to be like this for a long time to come, no matter what we do," said Hardy, 25, of Atlanta. "I think some people in America don't want to know about all this violence, about all the killings. The people back home are shielded from it; they get it sugar-coated."

While senior military officials and the Bush administration say the president's decision to send more American troops to pacify Baghdad will succeed, many of the soldiers who're already there say it's a lost cause.

"What is victory supposed to look like? Every time we turn around and go in a new area there's somebody new waiting to kill us," said Sgt. 1st Class Herbert Gill, 29, of Pulaski, Tenn., as his Humvee rumbled down a dark Baghdad highway one evening last week. "Sunnis and Shiites have been fighting for thousands of years, and we're not going to change that overnight."

"Once more raids start happening, they'll (insurgents) melt away," said Gill, who serves with the 1st Infantry Division in east Baghdad. "And then two or three months later, when we leave and say it was a success, they'll come back."

Soldiers interviewed across east Baghdad, home to more than half the city's 8 million people, said the violence is so out of control that while a surge of 21,500 more American troops may momentarily suppress it, the notion that U.S. forces can bring lasting security to Iraq is misguided. ### **MILITARY WANTS MORE CIVILIANS TO HELP IN IRAQ**

WASHINGTON, Feb. 6 — Senior military officers, including members of the Joint Chiefs of Staff, have told President Bush and Defense Secretary Robert M. Gates that the new Iraq strategy could fail unless more civilian agencies step forward quickly to carry out plans for reconstruction and political development.

The complaints reflect fresh tensions between the Pentagon and the State Department over personnel demands that have fallen most heavily on the military. But they also draw on a deeper reservoir of concerns among officers who have warned that a military buildup alone cannot solve Iraq's problems, and who now fear that the military will bear a disproportionate burden if Mr. Bush's strategy falls short. ### **U.S. THREATENS CRUSHING OFFENSIVE TO CALM BAGHDAD**

BAGHDAD -- A U.S.-Iraqi offensive against militants in Baghdad will begin within days and take place on a scale never seen during four years of war, American officers said yesterday.

... Briefing a small group of foreign reporters, three American colonels who are senior advisers to the Iraqi army and police in Baghdad said a command center overseeing the crackdown in the capital would be activated today.

"The expectation is the plan will be implemented very soon thereafter," a senior adviser to the 9th Iraqi army division said at a U.S. military base in Baghdad.

"It's going to be an operation unlike anything this city has seen," Col. Doug Heckman added. "It's a multiple-order magnitude of difference, not just a 30 percent, I mean a couple hundred percent" larger than previous offensives.

### **HOW THE US SENT \$12BN IN CASH TO IRAQ. AND WATCHED IT VANISH**

Special flights brought in tonnes of banknotes which disappeared into the war zone

The US flew nearly \$12bn in shrink-wrapped \$100 bills into Iraq, then distributed the cash with no proper control over who was receiving it and how it was being spent. The staggering scale of the biggest transfer of cash in the history of the Federal Reserve has been graphically laid bare by a US congressional committee.

In the year after the invasion of Iraq in 2003 nearly 281 million notes, weighing 363 tonnes, were sent from New York to Baghdad for disbursement to Iraqi ministries and US contractors. Using C-130 planes, the deliveries took place once or twice a month with the biggest of \$2,401,600,000 on June 22 2004, six days before the handover.

... The minutes from a May 2004 CPA meeting reveal "a single disbursement of \$500m in security funding labelled merely 'TBD', meaning 'to be determined'." The memorandum concludes: "Many of the funds appear to have been lost to corruption and waste ...

thousands of 'ghost employees' were receiving pay cheques from Iraqi ministries under the CPA's control. Some of the funds could have enriched both criminals and insurgents fighting the United States."

According to Stuart Bowen, the special inspector general for Iraq reconstruction, the \$8.8bn funds to Iraqi ministries were disbursed "without assurance the monies were properly used or accounted for". But, according to the memorandum, "he now believes that the lack of accountability and transparency extended to the entire \$20bn expended by the CPA".

## **ARMY PROBES WAR CONTRACTOR FRAUD**

From high-dollar fraud to conspiracy to bribery and bid rigging, Army investigators have opened up to 50 criminal probes involving battlefield contractors in the war in Iraq and the U.S. fight against terrorism, The Associated Press has learned. Senior contracting officials, government employees, residents of other countries and, in some cases, U.S. military personnel have been implicated in millions of dollars of fraud allegations.

"All of these involve operations in Iraq, Afghanistan and Kuwait," Chris Grey, a spokesman for the U.S. Army Criminal Investigation Command, confirmed Saturday to the AP. "CID agents will pursue leads and the truth wherever it may take us," Grey said. "We take this very seriously."

Battlefield contractors have been implicated in allegations of fraud and abuse since the war in Iraq began in spring 2003. A special inspector general office that focused solely on reconstruction spending in Iraq developed cases that led to four criminal convictions. The problems stem in part from the Pentagon's struggle to get a handle on the unprecedented number of contractors now helping run the nation's wars. Contractors are used in battle zones to do nearly everything but fight. They run cafeterias and laundries for troops, move supplies, run communication systems and repair weapons systems.

## **ARMY SAYS IT WILL WITHHOLD \$19.6 MILLION FROM HALLIBURTON, CITING POTENTIAL CONTRACT BREACH**

WASHINGTON, Feb. 7 — The Army announced during a House oversight committee hearing on Wednesday that it would withhold \$19.6 million from the Halliburton Company after recently discovering that the contractor had hired the company Blackwater USA to provide armed security guards in [Iraq](#), a potential breach of its government contract.

The Army has said that its contracts with Halliburton, which has a five-year, \$16 billion deal to support American military operations in Iraq, generally barred the company and its subcontractors from using private armed guards. ## **WATADA COURT-MARTIAL ENDS IN MISTRIAL**

Fort Lewis, Washington - The court-martial of First Lt. Ehren Watada, a commissioned US Army officer who refused deployment to Iraq on the basis that he believed the war was illegal, has ended in a mistrial, a military court judge ruled Wednesday.

In a stunning defeat for military prosecutors, Lt. Col. John Head, the military judge presiding over Watada's court-martial, said he had no choice but to declare a mistrial because military prosecutors and Watada's defense attorney could not reach an agreement regarding the characterization of a stipulation agreement Watada signed before the start of his court-martial. The government characterizes the stipulation agreement as an admission of guilt by Watada for "missing movement" and making statements against the Iraq war that resulted in charges of conduct unbecoming an officer and a gentleman.

### **TESTER BLASTS VA: 'VETERANS ARE HURTING'**

WASHINGTON — Sen. Jon Tester, D-Mont., blasted the administration Thursday for trying to run the Department of Veterans Affairs “on the cheap” and said the VA delays treatments for veterans seeking health care long enough that they give up.

“I think this is very widespread and quite frankly it disturbs me a bunch that this country makes promises to people, sends them into war and then comes back and says, you know what, we’ll just string you out until you forget about it,” he said.

The lack of funding stems from the administration’s vision, he said. “I think that somebody said a while back they’ve been trying to do this war on the cheap, and I think they’re trying to do the VA on the cheap,” he said.

“Delay is denial,” he added. “Delay happens far more often than it should. They are running these folks around, and they’re running ‘em around because they don’t have enough money. And to top that off, they’re also burning out the personnel who are giving treatment.” ... “I don’t care what it says on the Web sites, I don’t care what folks in the administration are saying, there’s a lot of veterans out there who are hurting,” he said. “They’re waiting in line for health care and they shouldn’t be.”

### **THIS MARINE’S DEATH CAME AFTER HE SERVED IN IRAQ**

When Jonathan Schulze came home from Iraq, he tried to live a normal life. But the war kept that from happening. At first, Jonathan Schulze tried to live with the nightmares and the grief he brought home from Iraq. He was a tough kid from central Minnesota, and more than that, a U.S. Marine to the core. Yet his moods when he returned home told another story. He sobbed on his parents' couch as he told them how fellow Marines had died, and how he, a machine gunner, had killed the enemy. In his sleep, he screamed the names of dead comrades. He had visited a psychiatrist at the VA hospital in Minneapolis. Two weeks ago, Schulze went to the VA hospital in St. Cloud. He told a staff member he was thinking of killing himself, and asked to be admitted to the mental health unit, said his father and stepmother, who accompanied him. They said he was told he couldn't be admitted that day. The next day, as he spoke to a counselor in St. Cloud by phone, he was told he was No. 26 on the waiting list, his parents said.

Four days later, Schulze, 25, committed suicide in his New Prague home.

WASHINGTON, Feb. 8 /PRNewswire-USNewswire/ -- "We recognize that the budget recommendation VVA is making this year -- an increase of \$6.9 billion over the expected fiscal year 2007 appropriation for veterans' health care -- is extraordinary," John Rowan, National President of Vietnam Veterans of America said in testimony before the House Committee on Veterans' Affairs this morning.

"But with troops in the field, years of under-funding of health care organizational capacity, renovation of an archaic and dilapidated infrastructure, updating capital equipment, continued underestimation of usage by veterans, particularly returnees from Iraq and Afghanistan, and several cohorts of war veterans reaching ages of peak health care utilization, these are extraordinary times," Rowan said. "It's past time to meet these needs.

"The \$2 billion increase the Administration has requested for medical care may almost keep pace with medical inflation," Rowan said in testimony submitted for the record. "But it will not allow VA to enhance its health care or mental health care services for returning veterans, restore diminished staff in key disciplines, restore needed long-term care programs for aging veterans, or allow working-class veterans to return to their health care system.

## **DECORATED AIR FORCE RESERVE NURSE SUES SUTTER HEALTH FOR FIRING HER AFTER DEPLOYMENT TO IRAQ**

Major California Hospital Network Violated Federal and State Employment Laws, Suit Charges

[SAN FRANCISCO, January 23, 2007] Lieutenant Colonel Debra Muhl has served with distinction in the United States Air Force for more than 30 years, saving the lives of American soldiers in combat zones in Somalia, Bosnia, Afghanistan and Iraq. For her valor, she has received more than 20 medals – but she never expected what she received from her civilian employer, the northern California-based health giant, Sutter Health, when she told them that she was being deployed to Iraq: a pink slip.

Today, Lt. Col. Muhl filed a lawsuit in U.S. District Court in San Francisco, charging that Sutter Health violated the Uniformed Services Employment and Reemployment Rights Act of 1994, a law specifically passed by Congress to protect the civilian jobs of members of the Reserves and National Guard. Lt. Col. Muhl is represented by attorney David A. Lowe, a Partner of the San Francisco-based law firm Rudy, Exelrod & Zieff.

"Lt. Col. Debra Muhl is a war hero," said attorney Lowe. "She has been honored with three Meritorious Service Medals, an Air Medal for flying combat missions, three Commendation Medals and other awards." She is no less accomplished in her civilian life: she was the administrative director of the Sutter Health's Joint Cardiac Program where she received outstanding performance evaluations. "The USERRA, as well as the California Military and Veterans Code, exist precisely to protect the civilian jobs of dedicated public servants like Lt. Col. Muhl, who selflessly answered the call to serve in our country's military reserves," said Lowe. "Yet Sutter Health ignored its obligations under those laws and fired Lt. Col. #### **VETERANS HOME AFFORDABLE HOUSING DEAL DEAD**

BRISTOL - A Warwick-based organization that provides housing for homeless and low-income veterans and their families has apparently abandoned a plan to build 10 affordable housing units at the Rhode Island Veterans Home on Metacom Avenue. Operation Stand Down, which as recently as November had received a \$1.5 million federal grant to help build the units, had faced opposition to its plan from state and local officials. The most notable was Rep. Raymond E. Gallison Jr., a member of a House of Representatives commission studying the veterans' home future and the head of a separate committee examining homeless veterans in Rhode Island.

#### **MILITARY TO CUT BACK ON 'STOP LOSS'**

WASHINGTON - In an action branded a backdoor draft by some critics, the military over the past several years has held tens of thousands of Soldiers, Sailors, Airmen and Marines on the job and in war zones beyond their retirement dates or enlistment length. It is a widely disliked practice that the Pentagon, under new Defense Secretary Robert Gates, is trying to figure out how to cut back on. Gates has ordered that the practice - known as "stop loss" - must "be minimized." At the same time, he is looking for ways to decrease the hardship for troops and their families, recruit more people for a larger military and reassess how the active duty and reserves are used.

"It's long overdue," said Jules Lobel, vice president of the Center for Constitutional Rights and lawyer for some in the military who have challenged the policy in court.

"It has created terrible problems of morale," Lobel said last week. "It has in some cases made Soldiers feel that they were duped or deceived in how they were recruited."

Gates has asked the chief of each service branch for a plan by the end of February on how they would rely less on stop loss. <More at: <http://www.military.com/NewsContent/0,13319,123574,00.html>>

#### **WWII VET WINS \$254M IN LOTTERY**

CHESTERFIELD, Missouri - A World War II veteran and his family stepped forward Monday to claim a lottery jackpot worth more than a quarter-billion dollars, one of the largest single-ticket lottery prizes in U.S. history.

Jim Wilson II, 84, and his wife, Shirley, 79, claimed the winning prize from last Wednesday's drawing, along with their three sons.

"I was absolutely astonished," said Jim Wilson, a retired electrician who served in the Army's 82nd Airborne Division in Africa and Europe, at an afternoon news conference. "I couldn't believe it, and still don't."

## **TAPS – PASSINGS AND WAR STATISTICS**

### **NATIONAL GUARD AND RESERVE MOBILIZED AS OF FEBRUARY 7, 2007**

This week, the Navy and Air Force announced an increase, while the Army, Marine Corps and Coast Guard had a decrease. The net collective result is 2,627 fewer reservists mobilized than last week.

At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. Total number currently on active duty in support of the partial mobilization for the Army National Guard and Army Reserve is 72,195; Navy Reserve, 5,550; Air National Guard and Air Force Reserve, 5,657; Marine Corps

Reserve, 5,480; and the Coast Guard Reserve, 303. This brings the total National Guard and Reserve personnel, who have been mobilized, to 89,185, including both units and individual augmentees. ### THEY EVEN SPIN DEATH AND WOUNDING! THE DOD'S OBSCURE DEFINITION OF 'CASUALTY'

For the last few months, anyone who consulted the Veterans Affairs Department's Web site to learn how many American troops had been wounded in Iraq and Afghanistan would have found this number: 50,508. But on Jan. 10, without explanation, the figure plummeted to 21,649.

Which number is correct? The answer depends on a larger question, the definition of wounded. If the term includes combat or "hostile" injuries inflicted by the enemy, the definition the Pentagon uses, the smaller number would be right.

But if it also applies to injuries from accidents like vehicle crashes and to mental and physical illnesses that developed in the war zone, the meaning that veterans' groups favor, 50,508 would be accurate.

The problem here is honestly reporting what is happening with our troops in a clear and understandable way to the American public. While the NYT cites the 'wounded' definition being the crux of the problem, I think it's the military definition for 'casualty' which needs greater inspection.

Most average people should not be expected to figure out for themselves that casualties reported by our Defense Department consist only of those who received "hostile" wounds in battle.

Most of us would think that anyone riding in a convoy in a war zone who gets severely wounded in an accident, or is incapacitated and unable to return to the combat zone due to PTSD, would be counted a casualty of war.

Not so -- even though the DoD's *own definition* for 'casualty' includes these injuries and more. From the Department of Defense Dictionary of Military and Associated Terms (last updated on January 5, 2007) [pdf]:

Casualty: Any person who is lost to the organization by reasons of having been declared dead, missing, captured, interned, wounded, injured, or seriously ill.

... Does the military think the American people just can't handle the truth? ### SUPPORT THE SEVERELY WOUNDED

Two years ago, Pentagon chief Donnie Rumsfeld said, "I think we ought to put together a team to see that the [military] services take care of their troops after they're wounded, and when they return home and are discharged."

Golly... what a concept. You get injured in war, you get help back home. Yes, I'm for that. Aren't you? Why this took so long to start, I don't know. Bear in mind that Rummy was talking about a special effort for severely wounded troops – these with amputations, brain trauma, and such. So, the brass set up MSIC, the Military Severely Injured Center. Headquartered just outside Washington, MSIC's goal was both clear and proper: "Seamless support as long as it may take to ensure that injured service members and families achieve the highest level of functioning and quality of life."

The center placed "counselor advocates" in 19 hospital across the country to work with the wounded vets on everything from financial needs to family problems, offering 24/7 support. Way to go – that's what I call really supporting our troops!

But wait... what the blankety-blank is this? The Pentagon has just shut down MSIC! In January, dozens of these skilled special advocates were abruptly shown the door. Even in the few hospitals where the advocates were not laid off, they're being reassigned and are not allowed to work with the severely wounded. The Pentagon says that MSIC was a duplication of efforts, thus expendable. But, as the head of a troop support group says: "I'm just livid about this. [MSIC] did a fabulous job for these families... who are hanging by a thread... No other organization helped service members and their families like they did."

This is Jim Hightower saying... Ironically, this despicable cut-back came only days before George W's state-of-the-union speech, where he called on Americans to support our troops. We do George! Why don't you? <http://jimhightower.com/node/6038>

### **VA BUDGET REQUEST SEEKS \$87 BILLION**

Published on Feb. 5, 2007 President Bush's fiscal 2008 budget request for the Department of Veterans Affairs calls for \$36.6 billion for discretionary veterans' medical care, an 83 percent increase since Bush took office in 2001, [AT WHICH TIME WE WERE AT WAR WITH NO ONE] according to the Office of Management and Budget. VA Secretary Jim Nicholson said the overall VA budget request seeks nearly \$87 billion for fiscal 2008, an increase of \$37.8 billion, or 77 percent, since 2001 [WHILE INJURIES AND DEATHS WENT FROM 0 TO WHAT?]. Health care and disability compensation for veterans would receive the majority of the proposed spending under the budget released today.

The request includes \$1.85 billion for information technology, a boost of \$782 million from the fiscal 2007 budget request. The VA received \$1.2 billion for IT in fiscal 2006. [APPARENTLY THIS WILL HELP THEM REPLACE SOME OF THOSE LAPTOPS THAT THEY KEEP LOSING]

Under the proposed budget, the VA said it would begin a new initiative [1,950 DAYS AFTER THE START OF OEF AND 1,421 DAYS AFTER THE START OF OIF WE HAVE A NEW INITIATIVE!] and to provide priority processing of claims for disability compensation from veterans of the war on terror [WHAT A CONCEPT!].
