### WHATEVER HAPPENED TO THE WAR?

Last week, according to the Pew Research Center, national news media provided 2% of their coverage on the wars. They spent twice as much coverage on Heath Ledger, five times as much on the stimulus plan, and 20 times as much on the 2008 campaign.

When asked what they had heard about in the news lately, readers responded with Obama – 24%, Clinton – 23%, Ledger – 11%, Britney Spears – 6% and on down to Mitt Romney 3%. They did NOT MENTION THE IRAQ OR AFGHANISTAN WARS!

Even when asked what they might be interested in reading or hearing about, only 6% mentioned the war.

No one anywhere mentioned the corollaries of war – the effect on veterans and their families, the provision of benefits and services, the reconstitution of the vastly depleted forces, both federal and state.

I spend hours daily reviewing news stories from all over the nation. It is getting harder and harder to find substantive news stories on the war or veterans. There are more stories on naming parks and post offices for dead veterans than there are on failing hospitals and programs for live veterans.

In Congress there are more unfunded provisions for veterans than there are funded ones, and there is much more opened-and-died-in-committee legislation than there is legislation with any substantial benefit for today's veterans commensurate with their sacrifice.

So whatever happened to the war?

Let's start with the first war – Afghanistan.

THEY'RE BAAAACK!! The Taliban is back in force. They control many areas in the south and along the Pakistan border. They are increasingly infiltrating the cities with suicide bombers and paramilitary fighters. A suicide bomber killed the deputy governor of Helmand province last week.

They have engaged in set-piece battles with NATO forces, particularly in the south. NATO casualties are rising, as are Afghani casualties, military and civilian. The condition of women is returning rapidly to the situation under the old Taliban, and female school teachers and women running businesses are increasingly being targeted for terrorist assaults and assassinations.

The only progress seems to be that opium is once again a bumper crop, and Mullah Mohammed, bowing to international pressure, has

told his forces to stop beheading the people they terrorize and shoot them or hang them instead. - That's it after almost six years?

Then of course there is Iraq.

The surge has worked – in Baghdad at least. The killings are down – not done, but down. They may be coming back up.

We are arming the Iraqi forces with modern American weapons, although we know that those forces are infiltrated by the militias.

We are bribing the Sunni leadership to do what they already know they must do and would probably have done without our money, and that is get rid of the Al Qaida-in-Iraq thugs.

In the Shia area the state of women has reverted not just to pre-Saddam conditions, but to pre-20<sup>th</sup> century conditions.

The Maliki government is effectively forming our foreign policy in the region in that they refuse to do anything that we want them to do that might upset either the Shia mullahs or their Iranian neighbors. While we are paying the Sunni tribal leaders to supports us, and they are so far, Maliki is denying them even proportional parity in government.

There are disturbing reports that violence is increasing in the unattended countryside. The southern area around Basra is falling apart after the pull-back of the British forces. American casualties almost doubled in January over December.

Then there is the war as it is waged right here in the US of A. Given that half of America doesn't even seem to care to participate, even to give the war a thought from day to day, the remaining half are waging a war here at home over what it means to be patriotic, what the Constitution says about war and the powers of government, what the United States' obligations are under international treaties, how we should conduct ourselves in the world, and what we owe those who stand up and sign up.

The divide seems to be between those who believe that the Constitution requires that in order to protect our freedoms we must not give them away willy-nilly, and those who believe that the Constitution is unclear, and who are afraid and are willing to sacrifice freedoms for a sense of security – real or not.

These are troublesome differences, because they speak to two completely different nations. One proudly free and democratic, and one willing to define something less than the historical concept of freedom and democracy as a new "freedom".

The cliché, "Freedom is not Free" is batted about with obviously varying meaning. To some that means "Freedom is not Free so please send your kid to fight wherever the CINC says to go."

We seem to forget that the original meaning was, "Freedom is not Free so all of you step up – all of you do your share – all of you sacrifice – all of you accept that you will always live under some insecurity." Why? Because it is truly worth it.

And don't forget that also means that "Freedom is not Free because we owe those who defend us daily everything that a grateful nation can offer." This does not mean collecting an additional \$1.2B from Tricare recipients, while giving away \$150B, mostly to banks who gambled and lost, and to people who can't control their spending.

We must pay a price for freedom, but we must not pay the price of real freedom to gain false freedom. Breaking down the protections and the checks and balances provisions of our Constitution are not worth it.

A unitary executive, not beholden to the peoples' representatives, is what our fathers fought against two centuries ago. Representatives who represent themselves rather than us are likewise not the legislative construct for which our fathers risked their "lives, fortunes and sacred honor." A judiciary that can set aside not only the clear precepts of the Constitution, but also can ignore two centuries of precedent would be anathema to those who gave us the precious gift called America.

We will prevail

We will come through this trying time, because we have proven again and again that we are strong enough to do so – that the structure of our nation as given us by our fathers is tough and resilient. To do that we will have to stop fighting each other and start writing the next chapter of our blessedly free world.

## RECALL - FEDERAL AND STATE LEGISLATION AND LEGISLATORS

### **PRESIDENT BUSH SIGNS H.R. 4986, THE NATIONAL DEFENSE AUTHORIZATION ACT FOR FISCAL YEAR 2008 INTO LAW**

Today, I have signed into law H.R. 4986, the National Defense Authorization Act for Fiscal Year 2008. The Act authorizes funding for the defense of the United States and its interests abroad, for military construction, and for national security-related energy programs.

Provisions of the Act, including sections 841, 846, 1079, and 1222, purport to impose requirements that could inhibit the President's ability to carry out his constitutional obligations to take care that the laws be faithfully executed, to protect national security, to supervise the executive branch, and to execute his authority as Commander in Chief. The executive branch shall construe such provisions in a manner consistent with the constitutional authority of the President.

WASHINGTON, D.C. - U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, introduced legislation today to increase veterans' compensation through a cost-of-living adjustment (COLA). A bipartisan group of Veterans' Affairs Committee Members signed on as original cosponsors of this legislation, including Ranking Member Burr, and Senators Rockefeller, Murray, Obama, Sanders, Brown, Webb, Tester, Craig, and Isakson.

"The COLA increase must be understood as a continuing cost of war. This legislation is necessary to protect the value of the compensation disabled veterans and their survivors receive and rely upon," said Senator Akaka.

Chairman and majority Committee members urge VA to improve proposed regulations and repeal "10 percent rule"

WASHINGTON, D.C. - U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, was joined by Senators Rockefeller, Murray, Obama, Tester, Brown, and Sanders in submitting formal comments yesterday on regulations proposed by the Department of Veterans Affairs governing compensation for veterans with traumatic brain injury (TBI). TBI is a signature wound of the war in Iraq, affecting many veterans who have suffered IED blast injuries.

"The new rules must provide for a fair evaluation of the veteran's disabilities. Unfortunately, the proposed regulations do not," said Senator Akaka.

## **U.S. ARMY SHIFTS FOCUS TO NATION-BUILDING**

## **NEW STRYKER FARING POORLY IN FIELD**

BAQUBAH, Iraq - The newest version of the Army's popular Stryker combat vehicle is garnering poor reviews here from Soldiers assigned to man its tank-like hull.

The General Dynamics Corp.-built Mobile Gun System looks like a typical eight-wheeled Stryker, except for a massive 105mm gun mounted on its roof. The gun fires three different types of projectiles, including explosive rounds, tank-busters and a "canister round" that ejects hundreds of steel pellets similar to a shotgun shell.

But while the system looks good on paper and the Army's all for it, Soldiers with the 4th Battalion of the 9th Infantry Regiment -- one of the first units to receive the new vehicle for their deployment to Iraq -- don't have a lot of good things to say about it.

"I wish [the enemy] would just blow mine up so I could be done with it," said Spec. Kyle Handrahan, 22, of Anaheim, Calif., a tanker assigned to Alpha Company, 4/9's MGS platoon.

"It's a piece," another MGS platoon member chimed in. "Nothing works on it."

## **OUTLAWED JOB CONVERSIONS STILL IN 2009 BUDGET**

### **VA INCREASES TRAVEL REIMBURSEMENT FOR ELIGIBLE VETERANS, THEN TAKES MOST OF IT AWAY**

WASHINGTON (January 31, 2008) - Over a million eligible veterans will see their mileage reimbursement more than double starting tomorrow, for travel to Department of Veterans Affairs (VA) medical facilities.

"This increase helps veterans -- especially those living in rural areas -- offset some of the gasoline costs as they travel to VA's world-class health care," said Secretary of Veterans Affairs Dr. James B. Peake. "Increasing the mileage reimbursement is one more step by VA to help veterans access the health care they deserve."

The 2008 appropriations act provided funding for VA to increase the beneficiary travel mileage reimbursement rate from 11 cents per mile to 28.5 cents per mile. The increase goes into effect on Feb. 1.

After little more than a month on the job, Secretary Peake used his authority to establish the first increase in the mileage reimbursement in 30 years, fulfilling a pledge he made during his Senate confirmation hearing last month. While increasing the payment, VA, as mandated by law, also equally increased the deductible amounts applied to certain mileage reimbursements. The new deductibles are \$7.77 for a one way trip, \$15.54 for a round trip, with a maximum of \$46.62 per calendar month.

However, these deductibles can be waived if they cause a financial hardship to the veteran.

I don't know how the VA figures the mileage.. must be from edge of town or center..My mileage from my House to VAMC 76.4 miles, round trip...it should be \$21.80...but they figure it a lot less.

I never accepted my \$1.26.. I go to window with my slip.. When she tells me how much, I tell them to keep it they surely need it more than me... You figure it at 20 Miles per gallon at \$3.00 a gallon..plus wear & tear & Insurance it still don't come close to expense... and is a lot less than what a VA employee gets for travel - 48.5 per mile in 2007 2008 will be out soon from GSA

## **MULLEN: ARMY MUST RETURN TO 12-MONTH TOURS**

WASHINGTON — The top uniformed military officer on Wednesday described a tired U.S. military force, worn thin by operations in Iraq and Afghanistan and unlikely to come home in large numbers anytime soon.

The assessment comes as President Bush decides whether to continue troop reductions in Iraq — possibly endangering fragile security gains made in recent months — or not, and risk straining ground forces further.

"The well is deep, but it is not infinite," Adm. Michael Mullen, chairman of the Joint Chiefs of Staff, told the Senate Armed Services Committee. "We must get Army deployments down to 12 months as soon as possible. People are tired."

## **NEW WAR VETERANS FACE JOB WOES**

Strained by war, recently discharged veterans are having a harder time finding civilian jobs and are more likely to earn lower wages for years due partly to employer concerns about their mental health and overall skills, a government study says.

The Veterans Affairs Department report, obtained Thursday by The Associated Press, points to continuing problems with the Bush administration's efforts to help 4.4 million troops who have been discharged from active duty since 1990.

The 2007 study by the consulting firm Abt Associates Inc. found that 18 percent of the veterans were unemployed within one to three years of discharge, while one out of four who did find jobs earned less than \$21,840 a year. "Our military families also sacrifice for America," Bush said. "They endure sleepless nights and the daily struggle of providing for children while a loved one is serving far from home. ### **HURT GIS' MEDICAL STATUS ALTERED**

COLORADO SPRINGS — Army Staff Sgt. Jack Auble was in the process of being medically discharged after serving nearly 20 years in the military when he was sent to Baghdad last year.

Auble, 43, suffers from severe osteoporosis of the spine, bulging discs and compression fractures.

Auble had a "permanent" profile, meaning his condition would not improve, and because of his limitations, he did not meet the Army's retention standards.

Nevertheless, Auble's medical paperwork was changed. He received a new, "temporary" status, used to indicate his condition would improve, and he was redeployed. ### **BRAIN SCREENINGS FOR VETS MAY BE FLAWED**

WASHINGTON (AP) — Thousands of Iraq war veterans who could have suffered traumatic brain injury may be getting unnecessary or inadequate health care because Veterans Affairs officials have yet to determine whether their initial screening tests are reliable, investigators say.

A draft report by the Government Accountability Office, obtained this week by The Associated Press, highlights the Bush administration's continuing difficulties in treating traumatic brain injury, a leading problem among soldiers struck by roadside bombs in the Iraq war. It also comes as a provocative military study this week found that symptoms of memory loss and irritability that have been tied to brain injury might be more accurately attributed to post-traumatic stress and depression.

The GAO review of nine VA medical centers found that months after former VA Secretary Jim Nicholson in April promoted new screenings for brain injury and pledged personal responsibility in seeing them through, the department was still struggling to determine how to best gauge the clinical accuracy of its screenings.

In the report, the VA also acknowledged problems with follow-up appointments after veterans initially tested positive under the VA's screening tool. One medical center reported 27 cases in which their doctors failed to notify patients for additional evaluation because of glitches in the computerized program.

## TAPS – PASSINGS AND WAR STATISTICS

### NATIONAL GUARD AND RESERVE MOBILIZED AS OF FEBRUARY 6, 2008

This week the Army and Navy announced an increase, while the Marine Corps announced a decrease. The Air Force and Coast Guard numbers did not change. The net collective result is 843 more reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. The total number currently on active duty in support of the partial mobilization of the Army National Guard and Army Reserve is 74,041; Navy Reserve, 5,025; Air National Guard and Air Force Reserve, 7,231; Marine Corps Reserve, 8,693; and the Coast Guard Reserve, 334. This brings the total National Guard and Reserve personnel who have been mobilized to 95,324, including both units and individual augmentees. ### **ANTI-WAR CANDIDATES ARE TOP RECIPIENTS OF '08 DONATIONS FROM U.S. TROOPS**

Conservatives opposed to redeployment in Iraq have consistently claimed that U.S. troops are on their side:

President Bush: The [military] families gathered here understand that our troops want to finish the job. [[Link](#)]

Sen. John McCain (R-AZ): I want to — and I want to tell you something, sir. I just finished having Thanksgiving with the troops, and their message to you is — the message of these brave men and women who are serving over there is: Let us win. Let us win. [[Link](#)]

Yet U.S. troops disagree. Yesterday, the Center for Responsive Politics reported that members of the military donated the most not to McCain, but to [two anti-war candidates](#):

Individuals in the Army, Navy and Air Force made those branches of the armed services among the top contributors in the 4th Quarter, ranking No. 13, No. 18 and No. 21, respectively. In 2007, Republican Ron Paul, who opposes U.S. involvement in Iraq and Afghanistan, was the top recipient of money from donors in the military, collecting at least \$212,000 from them. Barack Obama, another war opponent, was second with about \$94,000.

These donations reflect the military's disapproval with the Iraq war and President Bush's handling of it. A recent Military Times poll found that just [46 percent of U.S. troops](#) now believe that the country should have invaded Iraq, and only 40 percent approve of Bush's handling of the war.

#### **ST. PAUL'S LAST VFW HALL TO CLOSE AS RANKS OF VETERANS DECLINE**

For St. Paul's last VFW hall, it's closing time.

On one recent afternoon, 84-year-old Gordon Kirk, commander of VFW Post 8854, was the only veteran in the place.

He drifted past the war memorabilia and a case packed with sports trophies from the 1960s. "We had some wonderful times here," he murmured.

Those memories, like the VFW, are fading. Kirk is planning to sell the building as soon as he can find a buyer.

It will be the last of about 15 halls to close, making all nine of the city's VFW posts homeless, meeting in community centers or libraries.

Across the country, the number of VFW posts is dropping, as an estimated 1,500 World War II veterans die each day. Membership has dropped about 17 percent since 1992 to 1.8 million members.

Minnesota is losing about six VFW posts a year and now has 268 -- down by one-third from the peak.
