#### FIRST CALL - NOTES FROM THE FRONT

#### THIS WE'LL DEFEND!

In the U.S. Army Emblem and Seal a rattlesnake holds a scroll with the words **"This We'll Defend"**. This motto sets a frame for all veterans today.

The question of course is what is the "This" that we will defend?

To define that just recall the oath we took upon enlistment or commissioning. "I will support and defend (uphold) the Constitution of the United States against all enemies, foreign and domestic; ... I will bear true faith and allegiance to the same."

Two interesting points about our oath. There is no duration defined in the oath: once taken, it is a lifetime affirmation. "So help me God" is optional to the individual rendering the oath as Article Six of the United States Constitution requires that there be no religious test for public office.

What is this Constitution that we have sworn to "support and defend"? In plain talk, it is one of the simplest constructs for government ever devised. We vets certainly don't need some demagogue or ideologue to explain it to us.

The <u>Declaration of Independence</u> had established in 1776 that in the view of Americans, all men are equal, all have equal rights, that the government that they establish for themselves exists to preserve those rights, and that government derives its power solely from the consent of these equal citizens.

Now all of that equality didn't apply originally to anyone but free, white males, but we straightened that out over the years.

In 1787 the Founders set about to define what sort of government we would have, and in 1789 the Constitution was approved. The idea is very simple. Following on the original declarations, the Preamble states that this whole government comes from "We the People", and there is no other source.

Article I recognizes that we can't run a country on pure participative democracy, where all citizens vote on all issues (true then and more so today), so we established a legislature of elected representatives who will protect our rights through the making of laws, and will ensure the orderly structure and conduct of government through the raising of taxes. The sole power to raise an armed force, to make rules for that force, and to declare war rest with the legislature only.

**Article II** then addresses how the government will be run and establishes the Executive office of the President. It is his job to get the everyday business of government done. He establishes and fills offices to do the people's business. He is commander-in-chief of the armed forces. He can make treaties with other governments. Most of these powers are with the "advice and consent of the Senate".

**Article III** then sets up the organization to protect the people and to keep the Legislature and the Executive honest – the Courts. It establishes the Supreme Court which may establish lesser courts. Later *Marbury v Madison* empowered the Supreme Court to decide on the Constitutionality of all laws.

**Article IV** establishes the relationship of the various States to the Federal Government.

**Article V** says, in essence, "we know we didn't get it all right for all time, so this is how you may amend this Constitution." They made it hard to do.

Article VII establishes the criteria for ratification.

That's it. You now know almost as much as the Supreme Court.

There was an obvious need, as expressed by the individual states, to list the rights of citizens within the body of the Constitution; so the very first ten amendments – the Bill of Rights – were added in 1791.

Many of the subsequent amendments were process and housekeeping with notable exceptions:

Amendment XIII abolishing slavery – 1865.

Amendment XIV, Section 1 – due process – 1868.

**Amendment XV** – the right of all males to vote – 1870.

Amendment XVI – the income tax – 1913.

**Amendment XIX** – the right of women to vote – 1920.

Amendment XXIV - abolishing poll taxes – 1964. There you have it. "This We'll Defend."

So why do so many veterans show up at antigovernment rallies – wearing their paraphernalia so that they can be clearly identified as vets – and espouse positions that defy the Constitution?

Why do so many vets oppose others' free speech when they presents a position on issues they disagree with? The films of this last year's town meetings on healthcare present too many examples of this anti-Constitutional behavior by vets. **Amendment I**.

Why do so many vets join rallies against the census – a task that is clearly listed in **Article I**, **Section 2**. [this Section also contains the infamous "three-fifths of all other persons" clause.]

Why do so many vets, in their rightful and proper support of **Amendment II**, insist that there should be no controls whatsoever on owning guns, when we demand controls on almost every other form of ownership from cars, to homes, to banking and investment accounts? Why do those who know guns best demand that any nutcase who wants to can own an assault rifle? Why do they insist that the phrase "A well regulated militia, being necessary to the security of a free State" has no meaning?

Why do so many vets support the view that the President can take us to war? The national vets organizations gave loud support to the President's initiating the Iraq War despite **Article I's** prohibition. Why do so many vets oppose taxes in all forms? We all oppose the misuse of our tax money, but taxes themselves are the price of citizenship – **Article I**, **Section 8**.

Why do so many vets publicly support a religious basis for government? **Article VI**.

Why do so many vets support illegal acts such as torture, warrantless wire-tapping, and denial of *habeas corpus*? What happened to **Article I**, Section 9, **Amendment IV** and **Amendment VIII**?

Why do so many vets support inequality, whether it is for women or gays, or people of color? The Declaration and the Constitution throughout trumpet equality for all.

Finally, why do so many vets buy into the current atmosphere of fear, and support the idea that all actions are right and proper – even and especially those that violate our Constitution – if they can be attributed to the need to protect us from everything that might possibly threaten us, real or imagined?

There is no absolute protection from the threats that face us today. One crazy or one resolute effort by a terrorist organization can wreak havoc anywhere and at any time, if they desire. I believe that we should be extra vigilant, but we cannot give up that which makes us different – which is precisely what terrorists oppose.

Must we change the America we are sworn to defend into a cringing, quivering mass willing to throw away the blessings that our Constitution affirms for us on the off chance that someone might attack us?

That doesn't sound like "Defend": that sounds more like "Surrender".

If we change ourselves into what they want us to be – afraid of little ignorant criminals – they win regardless and we lose what we are sworn to defend.

So I ask all of my fellow veterans to reexamine where they stand relative to their oath – remember, oaths aren't like licenses or fruit; they don't expire.

Bring the courage you brought with you when you took that oath and when you served.

Reaffirm for yourselves and to your fellow citizens that **"This We'll Defend".**

# COMMITTEE PASSES INNOVATIVE BIPARTISAN BILL TO ELIMINATE HOMELESSNESS FOR VETERANS

March 10, 2010

Washington, D.C. – On Wednesday, March 10, 2010, the House Committee on Veterans' Affairs led by Chairman Bob Filner (D-CA), approved five bills that would improve benefits and services to veterans provided by the Department of Veterans Affairs (VA).

H.R. 4810 - End Veteran Homelessness Act of 2010 (Filner);

H.R. 4592 – Energy Jobs for Veterans Act (Teague)

H.R. 3976, as amended – The Veterans Employment and Home Preservation Act of 2010 (Perriello)

H.R. 1879, as amended – National Guard Employment Protection Act of 2010 (Coffman)

H.R. 4667 – Veterans' Compensation Cost-of-Living Adjustment Act of 2010 (Perriello)

# AKAKA AND MAJORITY OF COMMITTEE MEMBERS SUPPORT OBAMA BUDGET FOR VETERANS, URGE ADDITIONAL INVESTMENTS

#### March 8, 2010

WASHINGTON, D.C. – Senate Veterans' Affairs Committee Chairman Daniel K. Akaka (D-HI) was joined by a majority of Committee members in recommending a \$380 million increase in discretionary funding above the President's VA budget proposal. This recommendation came in the Committee's views and estimates letter on the Fiscal Year 2011 budget for veterans' programs, submitted to the Senate Budget Committee Friday.

... Akaka and co-signers recommended the following additional discretionary investments for veterans programs:

- Upgrading an Aging Hospital Infrastructure: \$235 million for VA construction;
- Supporting Family Caregivers: \$57 million for a new program to support family caregivers, tied to Akaka's effort to
  establish a permanent caregivers support program;
- Helping Disabled Veterans Train for new Employment: \$20.5 million for Vocational Rehabilitation and Employment;
- Improving Technology: \$30 million for Information Technology;
- Investing for the Future: \$25.5 million for VA Research; and
- Strengthening Oversight within VA: \$12 million for the Office of Inspector General

Akaka and co-signers also recommended that the budget provide mandatory funding to avoid imposing a Cost-of-Living Adjustment round-down in the coming fiscal year and to support a reasonable increase in the Specially Adapted Housing Grant programs which make it possible for severely disabled veterans to live more independently in residential housing. <More at: <a href="http://www.vawatchdog.org/10/scva10/scva030810-1.htm">www.vawatchdog.org/10/scva10/scva030810-1.htm</a>

#### **BUYER-BOOZMAN BILL SPARKS ACTION TO HELP HOMELESS WOMEN VETERANS**

Washington, D.C. – Today, Congressmen Steve Buyer and John Boozman expressed appreciation that one of their legislative efforts, previously passed by the House to provide assistance to homeless women veterans, was emulated in the President's 2011 budget request.

The U.S. Department of Labor fiscal year 2011 budget request for its Veteran Employment and Training Service (VETS) includes an additional \$5 million to help homeless women veterans and homeless veterans with children. #### FAREWELL BUT NOT GOODBYE TO A GREAT SOLDIER

On 10 April 2010, at 1100 in Hangar 1050 of Naval Air Station, Forth Worth, TX, James L. Williams, MajGen USMC, CG, 4th Marine Division, Marine Forces Reserve will retire.

Then BrigGen Williams and his ACE staff at Camp Pendleton were the inspiration in 2005 for the founding of Veterans United For Truth. It was their concern for the troops, and their account of the difficulty that serving Marines and their families were having in 2004 that sparked us to action. Their plight was the impetus for the "Wartime Shared Sacrifice Act" which we wrote and which, in somewhat changed form, was passed without a dissenting vote by both the Assembly and the Senate of California in 2006, but was subsequently vetoed by Governor Schwarzenegger.

All of us at VUFT wish General Williams a long and healthy retirement, and we hope that the Marine Corps continues to find such inspirational leaders.

#### VETERAN SUES VA OVER REMOVAL OF UPSIDE-DOWN FLAG

The West L.A. man joins with the ACLU in a lawsuit that alleges his free-speech rights were denied in his protest of what he sees as commercialization of the VA's Brentwood medical center grounds.

Robert Rosebrock didn't see any action during his two-year stint as an Army draftee in the mid-1960s. He was a corporal who worked as a clerk and a driver for the commanding general at Schofield Barracks in Hawaii, after all. But he's made up for it with his two-year skirmish with officials at the Veterans Affairs hospital in Brentwood.

For 103 Sundays in a row, Rosebrock has led a group of military veterans in a protest of what they claim is the VA's commercialization of the sprawling Wilshire Boulevard medical center's grounds.

VA officials paid little attention for the first 65 Sundays to the small band of mostly aging veterans holding protest signs and displaying American flags outside the medical center's gates. Then Rosebrock turned that around by turning the flag upside down. When the 67-year-old West Los Angeles event planner attached the upended stars and stripes to the hospital grounds' fence as "a symbol of distress," federal police swooped in. An associate director of the hospital said she ordered police to take action because she considered the display to be "a desecration of the flag" and feared that mental health patients might have been sensitive to an "inappropriate display on VA property."

After that, Rosebrock and the other protesters were confronted each time they attached the flag to the fence upside down. Six times police cited Rosebrock for unauthorized demonstrations on VA property. The VA later requested that a federal court dismiss the citations. But on Feb. 28, VA police confiscated the protesters' upside-down flag when they refused to remove it from the fence.

On Tuesday, Rosebrock fired back by joining with the American Civil Liberties Union in a lawsuit that alleges the VA has denied his free-speech rights. The U.S. District Court complaint names Donna Beiter, director of the VA's Los Angeles healthcare system, and Ronald Mathis, the VA's police chief.

#### **CHIEF JUSTICE 'STARTLED' BY GOVERNMENT ERRORS IN VETERANS CASES**

When he was in private practice at Hogan & Hartson, Chief Justice John Roberts Jr. did not handle veterans' benefits claims. So, he understandably found "startling" information with which lawyers for veterans are only too familiar: In litigating with veterans, the government more often than not takes a position that is substantially unjustified.

In oral arguments Monday in *Astrue v. Ratliff*, an attorney fee case under the Equal Access to Justice Act, James Leach of Rapid City, S.D., told the Court that 42 percent of Social Security cases result in an EAJA attorney fee award.

"If it's 42 percent, that's quite a high number of cases in which the government's position is found substantially -- not substantially justified as well as legally erroneous," Leach said. "In veterans cases, it's even worse."

... ROBERTS: Counsel do you -- do you dispute your friend's statement that 42 percent of the time in Social Security cases the government's position is unjustified, and 70 percent of the time in veterans' cases?

YANG: Well, I think that reflects the stakes often, Your Honor. Oftentimes the government does not contest, for instance, the \$2,000 EAJA award and because it's the government, has to --

ROBERTS: So whenever it really makes a difference, 70 percent of the time the government's position is substantially unjustified?

#### VA STAFFERS FACE DISCIPLINE OVER TRAVEL, PORN

Department of Veterans Affairs investigators are calling for disciplinary action against several officials following an internal probe into the VA's special-events office in Washington. The officials include a director who took taxpayer-funded trips to Las Vegas and San Diego that included a sailing trip and a golf outing, records show.

The same official - Diane Hartmann, director of national programs and special events - also authorized herself to receive hundreds of hours of leave to which she wasn't entitled, according to a new report by the VA Office of Inspector General.

JOINT BASE BALAD, Iraq -- Two female Soldiers with Task Force 38, 3rd Battalion, 158th Aviation Regiment, exemplified the "we can do it" motto of women's history month. Spc. Crisma Albarran and Spc. Jessica Sprung, stationed here, volunteered as UH-60 Black Hawk door gunners, a role primarily occupied by male Soldiers.

"The majority of door gunners are dominated by males, and when you have a female come into the job it reminds us that we're not the only ones who can do the job," said Sgt. Daniel Rice, a crew chief and standardization instructor from New Ipswich, N.H. "They (women) can do the job just as well and in some cases better than us."

#### **GAYS IN MILITARY RULING CREATES DILEMMA FOR BRASS**

SEATTLE – A pressing legal reality for the "don't ask, don't tell" standard for gays serving in the military is that the 9th U.S. Circuit Court of Appeals has already struck down the way it's practiced in much of the Western United States. The 2008 ruling, while largely overlooked, would force the military to apply a much higher threshold in determining whether a service member should be dismissed for being gay.

The government declined to appeal the ruling by the three-judge panel, which leaves it standing as law in the nine states covered by the court. #### DUTCH LEADERS ANGRILY REJECT CONTENTION THAT ALLOWING GAY TROOPS UNDERMINED THEIR MILITARY

"Scandalous," declared one. "Way off the mark," fumed another.

Top Dutch leaders ditched their usual diplomacy Friday in an angry reaction to suggestions by a retired U.S. general that allowing openly gay soldiers to serve in their military was partially to blame for Europe's worst massacre since World War II.

The statement was made by John Sheehan, a former Marine general, before a Senate hearing Thursday on the U.S. military's "don't ask, don't tell" policy regarding gays and lesbians in its ranks. Sheehan opposes President Obama's pledge to lift the ban on openly homosexual soldiers, and tried to cite the Dutch as an object lesson.

... On Friday, Dutch Defense Minister Eimert van Middelkoop labeled Sheehan's comments "scandalous, and unworthy of a soldier."

"I have nothing more to say about it," Van Middelkoop added. But his boss, Prime Minister Jan Peter Balkenende, did.

"Toward Dutch troops, homosexual or heterosexual, it is way off the mark to talk like that about people and the work they do under very difficult circumstances," Balkenende told reporters.

He called Sheehan's remarks "irresponsible," but said he didn't intend to bring up the matter with Obama, since Sheehan, a former NATO commander, is already retired.

Sheehan said it was former Dutch defense chief of staff, Gen. Henk van den Breemen, who had suggested to him that allowing gays to serve openly in the military had undermined its readiness.

A research team at Harvard Medical School estimates 2,266 U.S. military veterans under the age of 65 died last year because they lacked health insurance and thus had reduced access to care. That figure is more than 14 times the number of deaths (155) suffered by U.S. troops in Afghanistan in 2008, and more than twice as many as have died (911 as of Oct. 31) since the war began in 2001.

#### VA SEEKS TO MAKE GETTING BENEFITS EASIER FOR VETS

WASHINGTON — The Veterans Affairs Department took steps Thursday to make it easier for veterans of the Iraq or Afghanistan wars to get disability benefits. To qualify for the new streamlined status, they must have malaria, West Nile Virus or one of seven other diseases.

The VA has proposed a regulation change that lets veterans qualify for benefits by showing only that they served in the recent conflicts, or in the Gulf War, and have a diagnosis of any of nine diseases. Called "presumptive status," it's easier to prove an illness stems from war service.

#### VA TO AUTOMATE AGENT ORANGE CLAIMS PROCESS

WASHINGTON — The Veterans Affairs Department plans to announce Tuesday that it will fully automate how it pays claims for illnesses related to exposure to the chemical Agent Orange to keep an overburdened system from collapse.

It is the VA's first effort at automating claims processing in its 80-year history, VA chief technology officer Peter Levin said. It comes as the agency struggles to cut a backlog of more than 1 million disability claims, appeals and other cases.

The system "is likely to break" if nothing is done, Levin said.

"Look, the bottom line is why the hell they didn't do [automation] 30 years ago," said John Rowan, national president of Vietnam Veterans of America. "The question is whether they will do it right."

VA Secretary Eric Shinseki took office last year and said no disability claim should take longer than four months to process. However, department records show that almost 40 percent take an average of 161 days to process, VA records show, and that will increase to 190 days without automation.

#### SHINSEKI PLEDGES TO FIX BROKEN VETERANS' SYSTEM

CHILLICOTHE, Ohio (AP) — Veterans Affairs Secretary Eric Shinseki said he's making it a top priority this year to tackle the backlog of disability claims that has American veterans waiting months — even years — to get financial compensation for their injuries.

Among those waiting for relief are sick Vietnam and Gulf War veterans to whom the former Army commander feels an allegiance and who have long felt ignored.

"I'm a kid out of the Vietnam era, I just have enough firsthand knowledge of folks walking around with lots of issues. # VA TO RECONSIDER BENEFITS FOR ILL GULF WAR VETS

WASHINGTON -- The Veterans Affairs Department says it will look again at the rejected claims of veterans who say their Gulf War service caused a mysterious illness, the first step toward potentially compensating them nearly two decades after the war ended.

VA Secretary Eric Shinseki said the decision is part of a "fresh, bold look" his department is taking to help veterans who have what's commonly called "Gulf War illness" and have long felt the government did little to help them. The VA says it also plans to improve training for medical staff who work with Gulf War vets, to make sure they do not simply tell vets that their symptoms are imaginary - as has happened to many over the years.

# RANKS OF HOMELESS VETERANS DROP 18 PERCENT

March 10, 2010

Wide-Ranging Partnerships and VA Commitment Credited

The number of Veterans homeless on a typical night dropped 18 percent as the Department of Veterans Affairs (VA) entered the second year of its campaign to eliminate homelessness among Veterans within five years.

"It will take the dedication, creativity and hard work of many parts of American society to end homelessness among Veterans," said Secretary of Veterans Affairs Eric K. Shinseki. "But mostly it takes the resolve to say: It is unacceptable for a single Veteran to spend the night on the streets of America."

VA's Community Homeless Assessment Local Education and Networking Groups (CHALENG), which conducts a widely cited, annual census of homeless Veterans, estimated 107,000 Veterans were homeless each night last year. That figure was 131,000 in 2008 and 154,000 in 2007.

"The reduction was achieved through VA's commitment to end homelessness among Veterans through enhanced collaboration with other federal, state, faith-based, Veteran service organizations and community partners," Shinseki said.

VA has approximately 4,000 agreements with community partners. Last year, more than 92,000 homeless Veterans were served by VA's specialized homeless programs. This is an increase of 15 percent from the previous year.

#### YOUNG VETERANS FACE STEEP UNEMPLOYMENT

More than 20% ages 18 to 24 can't find work, a problem attributed to a lack of education and job experience before entering the service.

Young combat veterans from Iraq and Afghanistan have another challenge waiting for them when they return home: steep unemployment.

More than 1 in 5 can't find work, according to data released Friday by the Labor Department.

The unemployment rate last year for veterans ages 18 to 24 reached 21.1%, compared to 16.6% for that age group as a whole.

In addition to the recession, veterans groups attribute the high jobless rate to a lack of education, job experience and job training in the years before entering the service. Also, many return home with health and mental health problems that make it difficult to find work.

... Reserve officers, who can face multiple deployments in just a few years, can often be especially vulnerable to chronic joblessness. #### SEXUAL ASSAULTS ON FEMALE SOLDIERS: DON'T ASK, DON'T TELL

What does it tell us that female soldiers deployed overseas stop drinking water after 7 p.m. to reduce the odds of being raped if they have to use the bathroom at night? Or that a soldier who was assaulted when she went out for a cigarette was afraid to report it for fear she would be demoted — for having gone out without her weapon? Or that, as Representative Jane Harman puts it, "a female soldier in Iraq is more likely to be raped by a fellow soldier than killed by enemy fire."

The fight over "Don't ask, don't tell" made headlines this winter as an issue of justice and history and the social evolution of our military institutions. We've heard much less about another set of hearings in the House Armed Services Committee. Maybe that's because too many commanders still don't ask, and too many victims still won't tell, about the levels of violence endured by women in uniform

The Pentagon's latest figures show that nearly 3,000 women were sexually assaulted in fiscal year 2008, up 9% from the year before; among women serving in Iraq and Afghanistan, the number rose 25%. #### LAW OFFICERS STRUGGLE TO READJUST AFTER WAR

MADISON, Wis. (AP) -- For soldiers patrolling in Iraq and Afghanistan, death can come from a bomb hidden in a trash pile or an innocent-looking face in the crowd. Returning home alive can depend on the quick turn of a steering wheel or pull of a trigger. Those heightened survival instincts don't always translate when those soldiers return home to their jobs as law enforcement officers.

In interviews with The Associated Press and in dozens of anecdotes compiled in a survey by the International Association of Chiefs of Police and the U.S. Bureau of Justice Assistance, officers described feeling compelled to use tactics they employed in war zones after they returned to work in the U.S. and feeling less patient toward the public they serve.
