## FIRST CALL – NOTES FROM THE FRONT

### REMEMBER ALL OF THEM!– MEMORIAL DAY 2008

I know that I am not the only one who objects to Memorial Day sales. I can't be! There have to be others who are appalled by the crassness of the practice. There have to be others who remember.

Our newspapers and televisions are swamped with the joyous celebration of Memorial Day. Take an extra day! Buy a mattress! Have a party! Celebrate the holiday by buying my stuff! Memorial holiday vacation specials! Buy my junk and make it your junk at great savings in honor of those who have died in the service of our country!

There was a time when this holiday was the most serious and somber observation in our nation. There were no sales. There were no parties. There were parades, but they were pretty serious affairs, with veterans of wars past, and serving members of the present parading in honor of their fallen comrades.

The parade's destination in smaller communities was often the local cemetery, where it culminated in the playing of "Taps" and the firing of a 21-gun salute over the graves of the fallen.

Now, if there is a parade, the destination is usually the mall, in the march of the patriotic credit cards. If there is an old-fashioned memorial, it mostly attended only by veterans. You can even get a credit card with a flag on it!

What has happened to us as a people? How can we not care? How is it American to be indifferent to what is happening to so many of our youth – the deaths, the maimings, the mental fracture of so many?

While we cannot subordinate ourselves completely to others' views, when did we stop caring about the opinions of others at all? When did we stop being Americans? Unless ...

Did it become American to be apathetic? Did it become American to be selfish, greedy, self-absorbed?

How does that make us strong? How does that continue our devotion and allegiance to a vibrant American democracy?

We must remember and we must speak out! We must demand that others also remember.

Those veterans who have returned to us crushed in body or mind have to be remembered and must be served. The families of those who have fallen, or who have returned damaged often beyond repair, must be remembered. They too continue to give every day for the rest of their lives. ### **THE TRUTH ABOUT VETERAN SUICIDES**

Eighteen American war veterans kill themselves every day. One thousand former soldiers receiving care from the Department of Veterans Affairs attempt suicide every month. More veterans are committing suicide than are dying in combat overseas. These are statistics that most Americans don't know, because the Bush administration has refused to tell them. Since the start of the Iraq War, the government has tried to present it as a war without casualties.

In fact, they never would have come to light were it not for [a class action lawsuit](#) brought by Veterans for Common Sense and Veterans United for Truth on behalf of the 1.7 million Americans who have served in Iraq and Afghanistan. The two groups allege the Department of Veterans Affairs has systematically denied mental health care and disability benefits to veterans returning from the conflict zones.

The case, officially known as *Veterans for Common Sense et al vs. Peake*, went to trial last month at a Federal Courthouse in San Francisco. The two sides are still filing briefs until May 19 and waiting for a ruling from Judge Samuel Conti, but the case is already having an impact. That's because over the course of the two week trial, the VA was compelled to produce a series of documents that show the extent of the crisis effecting wounded soldiers. <More at: <http://www.fpif.org/fpifxt/5219>>

### **INSPECTOR GENERAL REPORT FINDS THAT VA CONTINUES TO INACCURATELY REPORT PATIENT WAIT TIMES**

May 19, 2008

WASHINGTON, D.C. - Responding to a [report](#) by the Department of Veterans Affairs Inspector General (IG) on VA patients' waiting times today, U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, expressed concern that VA continues to report inaccurate data on wait times for health care appointments. The IG audit, which focused on VA health

care network, VISN 3, found that VA under-reported patient wait times, and that staff there failed to follow recommendations made by the IG in previous reports on the issue. Some VISN 3 employees reported to the IG that their superiors directed them to violate existing guidelines and directives, and deliberately manipulate data. <More at: <http://www.vawatchdog.org/08/scva08/scva051908-1.htm>>

### **RUSH TO FAILURE: WILL CONGRESS RESCUE MILITARY HEALTHCARE?**

Last week, this Democratic led Congress took action to rescue modern military healthcare. According to the *Washington Post*, Rep. Ike Skelton (D-Mo.), Chairman of the House Committee of Armed Services, in a bipartisan committee move inserted language in the 2009 defense authorization bill that would halt construction of replacement hospitals for Walter Reed Army Medical Center until the Department of Defense demonstrates that it can deliver world-class health services. Congressman Jack Murtha said: "Our service members and their families have been promised a world class medical facility. This language will ensure that we deliver on that promise." ### **WEBB GI BILL PASSES SENATE**

The Associated Press reports that the [Webb GI Bill](#) has passed the Senate. Senate Republicans have broken with President Bush to help Democrats add support for veterans and the unemployed to a bill paying for another year of the Iraq and Afghanistan wars.

The 75-22 vote also added billions of dollars in other domestic funds such as heating subsidies for the poor and money for fighting wildfires to the \$165 billion for the military operations overseas.

### **CONGRESS PASSES TAX RELIEF FOR MILITARY FAMILIES**

Congress moved on Thursday to ease the economic hardships of military families by passing a \$2 billion package of tax breaks. The Senate, by voice vote, approved the legislation that the House passed Tuesday on a 403-0 vote. It now goes to President Bush for his signature.

The legislation, supported by major service organizations, allows active-duty reservists to make penalty-free withdrawals from retirement plans and provides a tax credit for small business employers who make up the difference of wages lost to employees called to active duty. It makes thousands of veterans eligible for low-interest homeowner loans and makes permanent the ability to include combat pay as earned income for purposes of the Earned Income Tax Credit, which refunds payroll and income taxes to low-income people.

The measure also clarifies that those on active duty who file a joint tax return will be eligible for the economic stimulus rebate payment even if the spouse does not have a Social Security number.

### **HOUSE OF REPRESENTATIVES PASSES VETERANS LEGISLATION**

May 21, 2008

Washington, D.C. – House Veterans' Affairs Committee Chairman Bob Filner announced that a package of bills to honor our nation's veterans passed the House of Representatives. The action comes as the nation prepares to honor and remember our fallen heroes on Memorial Day weekend.

"This Memorial Day will take on a more profound and personal significance for many American families this year – those who are mourning the loss of one of their own and those who have loved ones far from home," stated Chairman Filner. "As a way to honor these heroes, I ask that we recommit ourselves to caring for and serving our veterans. The bills that were passed by the House reinforce our commitment to ensure that the contributions of our brave veterans are never forgotten."

Five of the bills approved by the House of Representatives address the health care needs of veterans, including a bill to authorize major medical facility projects and leases for Fiscal Year 2009.

1.H.R. 2790, as amended - To amend title 38, United States Code, to establish the position of Director of Physician Assistant Services within the office of the Under Secretary of Veterans Affairs for Health.

2. H.R. 3819 - To amend title 38, United States Code, to require the Secretary of Veterans Affairs to reimburse veterans receiving emergency treatment in non-Department of Veterans Affairs facilities for such treatment until such veterans are transferred to Department facilities, and for other purposes.
  3. H.R. 5729 - To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to provide comprehensive health care to children of Vietnam veterans born with Spina Bifida, and for other purposes.
  4. H.R. 5554, as amended - To amend title 38, United States Code, to expand and improve health care services available to veterans from the Department of Veterans Affairs for substance use disorders, and for other purposes.
  5. H.R. 5856 – To authorize major medical facility projects and major medical facility leases for the Department of Veterans Affairs for fiscal year 2009, and for other purposes.
- Five of the bills passed by the House address veterans' benefits, including one bill that would allow the Department of Veterans Affairs to use television media to inform veterans of the entitlements and benefits they have earned.
6. H.R. 3681 - To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to advertise in the national media to promote awareness of benefits under laws administered by the Secretary.
  7. H.R. 3889, as amended – To amend title 38, United States Code, to require the Secretary of Veterans Affairs to conduct a longitudinal study of the vocational rehabilitation programs administered by the Secretary.
  8. H.R. 5664, as amended – To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to update at least once every six years the plans and specifications for specially adapted housing furnished to veterans by the Secretary.
  9. H.R. 5826 – To increase, effective as of December 1, 2008, the rates of disability compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for survivors of certain service-connected disabled veterans, and for other purposes.
  10. H.R. 6048 – To amend the Servicemembers Civil Relief Act to provide for the protection of child custody arrangements for parents who are members of the Armed Forces deployed in support of a contingency operation.

Chairman Filner concluded: "More than 1.6 million troops have been deployed as a result of the current conflicts. There are 800,000 new veterans, and 325,000 of these heroes have accessed the VA health care system. Additionally, there are 23 million living veterans from previous conflicts. This Memorial Day, I am pleased that the Members of the House came together to pay tribute to all of the men and women who have courageously served our great nation – those that have fought in past wars and those that are in harm's way today." ### **NUMBER OF DISABLED VETS ON THE RISE**

WASHINGTON - Increasing numbers of U.S. troops have left the military with damaged bodies and minds, an ever-larger pool of disabled veterans that will cost the nation billions for decades to come — even as the total population of America's vets shrinks. Despite the decline in total vets ... the government expects to be spending \$59 billion a year to compensate injured warriors in 25 years, up from today's \$29 billion, according to internal documents obtained by The Associated Press. ### **PETRAEUS SAYS TROOPS REDUCTIONS COMING**

Gen. David Petraeus said Thursday that by September he could recommend further U.S. troop reductions in Iraq if security continues to improve. ... Petraeus has previously been reluctant to say when his next assessment of troop levels would be. In a hearing before the Senate Armed Services Committee on Thursday, the four-star Army general said conditions on the ground will still determine whether more troops can come home.

... On a less-optimistic note, Petraeus said it is unlikely that Iraqi security forces will take the lead in all provinces this year, as was recently predicted by the Defense Department. ## **MISBEHAVING ARMY RECRUITS PROMOTED FASTER**

### **Recruits With History Of Misconduct Also Go AWOL More**

WASHINGTON -- Soldiers who need special waivers to get into the Army because of bad behavior go AWOL more often and face more courts-martial. But they also get promoted faster and re-enlist at a higher rate, according to an internal military study obtained by The Associated Press. The Army study late last year concluded that taking a chance on a well-screened applicant with a criminal, bad driving or drug record usually pays off. And both the Army and the Marines have been bringing in more recruits with blemished records. Still, senior leaders have called for additional studies, to help determine the impact of the waivers on the Army.

## **PENTAGON BIGGEST OBSTACLE TO GI BILL**

WASHINGTON (AP) — Veterans groups say it's time to expand college aid for GIs, and Democrats want to use an election year to do it. Their biggest obstacle? The Pentagon. The Defense Department is lobbying against legislation proposed by Sen. Jim Webb, D-Va., that would guarantee a full-ride scholarship for service members to any in-state public university. According to defense officials, the plan would hurt its ability to retain service members because the new GI education bill would require only three years before the full benefit kicks in. The Defense Department wants the commitment to be extended to at least six years.

"We have no issue with the fact that Sen. Webb wishes to provide a more generous education benefit to troops," said Pentagon spokesman Geoff Morrell. "But we are certainly concerned that this would be eligible to them" so soon.

The Pentagon's opposition to Webb's bill underscores the difficulty the military has had in recruiting and retaining an all-volunteer force at a time when it is engaged in a war that is deeply unpopular with the American public.

... In recent months, the military has had to take creative steps to reach its desired troop numbers. ### **THE ARMY TRAINS A SKEPTICS CORPS TO BATTLE GROUPTHINK**

In the wake of chaos and a lethal insurgency in Iraq, blamed in no small part on poor decisions and a lack of planning at the highest levels, the U.S. Army has had a startling insight that is upending conventional thinking about how the military works. That epiphany is that the force needs fewer yes men.

To that end, one of the Army's top colleges has been quietly training its own cadre of devil's advocates for the past two years. Its graduates say their role is often misunderstood and that their mission has been greeted with trepidation and, on occasion, hostility. "What we're really doing is producing an in-house skeptic, and that creates instant antibodies," says Greg Fontenot, the program director. "It's been like storming the beach at Normandy," agrees Lt. Col. Paul Baumann, who was sent to assess the program's success in Iraq. "It's been ugly, but they didn't kick us out." ... ## **"REAL AMERICANS" GET UPSET WHEN THEY ARE REMINDED – TWO CASES**

### **MARINE CAN'T WEAR UNIFORM AT GRADUATION**

BLOOMER, Wis. -- A new Marine who's graduating from Bloomer High School this month won't be able to wear his military uniform during the commencement ceremony. The Bloomer School Board has denied Daniel Ligen's request to wear his Marine uniform.

Ligen finished his class work early in order to enlist and will be done with basic training at the San Diego Marine base by graduation May 31.

The board adopted a policy Monday night that requires a cap and gown be worn for graduation. There was a motion to allow an exception for military personnel, but it wasn't seconded. One board member says the denial is not an attempt to be unpatriotic, but the cap and gown celebrates education. ### VA STRUGGLES TO GEAR UP TO CARE FOR FEMALE VETERANS

Washington - Two nightmares haunt Robin Milonas.

While serving in Afghanistan in 2004 as an Army Reserve civil affairs officer, the former lieutenant colonel got lost in a minefield while leading a small convoy delivering school supplies to civilians. Even more troubling is the memory of a man who arrived at the main gate of Bagram Air Base carrying a young boy whose leg had been blown off by a land mine.

"I was an outgoing, energetic, determined good soldier who wanted to make the Army a career," said Milonas, of Puyallup, Wash., who just turned 50. "Now I am broken."

Milonas is one of roughly 180,000 women who've been deployed to Afghanistan and Iraq. While they don't officially serve in combat, they have experienced life in a war zone where there are no front lines. And as they return home, they're increasingly turning to an already overtaxed Department of Veterans Affairs for help. Last year, the VA treated more than 255,000 female veterans. ### BILL ON FEMALE VETS GETS VA THUMBS-DOWN

### VETERANS' GROUPS PUSHING FOR MORE PREDICTABLE VA FUNDING

A coalition of veterans' groups wants Congress to ensure that the Department of Veterans Affairs (VA) has predictable medical care funding to better treat injured soldiers returning from Iraq and Afghanistan. While more political attention has been paid to a possible expansion of education benefits for returning soldiers under a new GI bill, some veterans' groups are highlighting the need to improve VA's funding. The Disabled American Veterans (DAV) is leading a coalition of groups that are pressing lawmakers to approve advance appropriations for medical care as part of the VA's budget. This would give the VA much more certainty over its funding, as it would know its budget a year in advance. For example, funding for 2010 would have to be approved this year.

... Congress now appropriates VA medical care funds on an annual basis. Political squabbling has delayed VA funding in 13 of the past 14 years — something that has severely hampered the department's ability to plan and manage its healthcare system, according to DAV's talking points.

Perez, the post-traumatic stress disorder (PTSD) coordinator at a VA facility in Temple, Texas, wrote an email (PDF) to her subordinates stating: "Given that we have more and more compensation seeking veterans, I'd like to suggest that you refrain from giving a diagnosis of PTSD straight out. Consider a diagnosis of adjustment disorder, R/O [ruling out] PTSD ... we really don't ... have time to do the extensive testing that should be done to determine PTSD."

### **NATIONAL GUARD AND RESERVE MOBILIZED AS OF MAY 14, 2008**

This week the Army, Air Force and Navy announced a decrease, while the Marine Corps announced an increase. The Coast Guard number remained the same. The net collective result is 1,290 fewer reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. The total number currently on active duty in support of the partial mobilization of the Army National Guard and Army Reserve is 76,758; Navy Reserve, 4,805; Air National Guard and Air Force Reserve, 8,501; Marine Corps Reserve, 8,770; and the Coast Guard Reserve, 347. This brings the total National Guard and Reserve personnel who have been mobilized to 99,181, including both units and individual augmentees. Army recruiter Nils Aron Andersson sat behind the wheel of his brand-new Ford F-150, firing round after round into the truck's CD player and radio with a .22-caliber semiautomatic pistol. Spent cartridges littered the seats and floorboards, along with a paper pharmacy bag holding a prescription for the antidepressant Lexapro.

Andersson's wife, Cassy Walton, had been trying to reach the 25-year-old sergeant on his cell phone for hours. He finally picked up about 2 a.m. and told her he wanted to kill himself. Walton begged him to keep talking to her. Andersson told her he was on the top floor of a downtown Houston parking garage and ended the call. Marine who killed self, brother called victim of stress

A decorated Marine Corps staff sergeant who apparently fatally shot his brother before killing himself at the end of a long police chase in Arizona served four tours in Iraq, met President Bush and suffered from post-traumatic stress disorder, his wife said Thursday.

Pinal County sheriff's spokesman Mike Minter said no motive has been established for why Travis N. "T-Bo" Twiggs, 36, killed his 38-year-old brother, Willard J. "Will" Twiggs, and himself on Wednesday. Nor is it known why the brothers earlier in the week may have tried to commit suicide by attempting to drive their car into the Grand Canyon.
