MORE DISPATCHES FROM THE FRONT

For almost four years we at VUFT have been attempting to bring attention to the wrongs being perpetrated against our serving military and veterans. It is not that the stories haven't been out there, rather it is that some are hidden, and very few pay attention.

Every fifteen days in this newsletter we try to uncover some of the lesser-told stories, and we try to put associated stories together to expose some normally hidden contradiction or hypocrisy.

Let's talk about some of the things that we old soldiers are doing to try to right some of these wrongs. Please forgive me for the collective "soldier"; it's the easiest way to refer to all soldiers, sailors and airmen. I don't like the term "warrior" because it's ancient position as an honorific has been sullied by equating it with "berserker"; we are not that kind of soldier, nor are most of those serving today.

We have been good soldiers, fighting the fight hard, when the odds are really stacked against us. Most of us who are active in the organization are retired or former regular members of the various services, but our efforts have been focused on the plight of both the part-time soldiers and the regulars in the current era.

Being good soldiers, we have tried hard to have an effect within the system. We concentrated on appeals to sitting legislators and government officials. We have proposed and had sponsored legislation voted on, passed and then vetoed. We have written to the civilian leadership in the Department of Defense, only to find out from them that they are doing "a heckuva job".

After several years of such activity with very little response – not even acknowledgement of the correspondence, let alone recognition of the problem – we decided that there was another way. If the checks and balances of the Constitution were not going to be used by the current Executive and Legislative leaders, then we sure has hell could try it.

When we were given the opportunity to join in the lawsuit against the Department of Veterans Affairs and the Department of Justice, we signed on. This was not that easy a choice.

There is some inherent feeling in all present and former military that using the courts to get the people in your own profession to do their job is not a very soldierly thing to do. That feeling goes right along with the one experienced by many of us that making a claim against the government is somehow whining.

We have to get over all of that.

This lawsuit isn't about getting what's "owed" to a few million veterans. It isn't even about what's "fair". No, this suit is much larger than that.

This suit is about the obligations that 300 million Americans have for our country and its soldiers. This suit is about the Constitutional necessity for all branches of our government to perform as we and our representatives have told them to do in the laws.

This lawsuit is not some cry for cash, as so many are; there are no monetary damages being asked for. Rather, it is a cry for honor – it is a cry for dignity – it is a cry for performance by those public servants whose salaries we pay.

Through this lawsuit we have found our way to get the big kids' attention. We have sounded our battle cry. "You can no longer hide from your legal, moral and ethical obligations. Where you succeed we will praise you, but where you fail we will tell the truth to America."

We have told those who cower in their ivory towers that we will serve when called upon, but you had better be sure that we are truly needed and that fighting, killing and destroying is the only answer.

We have put them on notice that when we go to fight and then come home we have earned something far beyond a good day's pay.

We have put our lives on hold for you. We have bled and died for you. We have sacrificed our physical and mental health for you.

We have left our families behind while you stayed home with yours. Our families have grieved while your families played. Our families have suffered while yours prospered. Your children pursued their careers, while our sons and daughters put their careers on hold.

We have hurt others in your name and we want to know that what we did was not only right, but honorable. We have served with dignity – have you done as much?

We will lead in this fight and others will follow, because it is inherent in the American fighting man that he honors not the flag, or the commander so much as the nation that those symbols and persons stand for.

Even old communists know truth when they see it:

It will be a long fight; the war of neglect against veterans and their families has gone on for a long time. Much needs to be righted. Join us on the front lines! Take up the sword and sound the battle cry! [Ed.]

VETERANS GROUPS WIN ROUND IN FEDERAL COURT IN LAWSUIT AGAINST VA

A federal court judge sided with two veterans advocacy groups suing the Veterans Administration Tuesday, agreeing to add to evidence an explosive email written by a VA official that suggested counselors consider diagnosing war veterans who show signs of post traumatic stress disorder with a less serious condition.

... The groups want a judge to issue a preliminary injunction to force the VA to immediately treat veterans who show signs of PTSD and are at risk of suicide. Attorneys representing both organizations asked the judge to reopen their case and consider admitting Perez's email into evidence after another veterans group publicly disclosed it last month.

... "It was an honest mistake by a junior staff member," [DVA attorney] Bensing told the judge. "There really is nothing more to this matter. We submit that it should have no effect on this case."

[Judge Samuel] Conti was not swayed. He admitted the document into evidence, which is expected to have an impact on his ruling. <More at: www.pubrecord.org/index.php?option=com_content&task=view&id=118&Itemid=9>

HOUSE EXAMINES VA-DOD PROGRESS ON IMPROVEMENTS FOR WOUNDED WARRIORS

Washington, D.C. — Today, the House Committee on Veterans' Affairs held a hearing on the implementation of the wounded warrior provisions in the National Defense Authorization Act for Fiscal Year 2008.

"Over the past fifteen years, one commission and task force after another has called for measures to streamline the transition from military to civilian life, but such changes have not been implemented," Committee Ranking Member Steve Buyer (R-Ind.) said. ... the wounded warrior provisions must be implemented with a sense of urgency," Buyer said.

AS US MILITARY BUILDUP IN IRAQ ENDS, WHAT NEXT?

The military buildup in Iraq is about to end. But as the last of the five additional combat brigades now heads home, it leaves the country far safer than it was a year ago. Yet Iraq is still not ready to stand alone.

The departure of the 2nd Brigade, 3rd Infantry Division will lower U.S. troop levels there to roughly 142,000 U.S. personnel by mid-July — at least 7,000 more than before the buildup began early last year. But it also sets up pivotal questions about how many more can come home in this election year, and whether the decline in violence can be maintained by the fledgling Iraqi security forces.

Two reports released Monday laid out significant political, economic and security progress in Iraq. But both cautioned that the country remains unstable and volatile. The quarterly Iraq progress report issued by the Pentagon warned that Iran and Syria continue to provide safe havens for terrorists, and allow them to travel across the borders into Iraq. It also repeated concerns that Iran's Quds Force, an elite unit of its Revolutionary Guards, continues to supply both weapons and training for militants in Iraq.

On the domestic side, the report sounded a pessimistic tone, saying the government of Iraq still struggles to enact its budget and fund large projects to rebuild its infrastructure.

The government, it said, "lacks the ability to execute programs on the scale required," and economic improvements remain "fragile, reversible and uneven." <More at: http://news.yahoo.com/s/ap/20080623/ap_on_go_ca_st_pe/us_iraq_3>

REPORTERS SAY NETWORKS PUT WARS ON BACK BURNER

Getting a story on the evening news isn't easy for any correspondent. And for reporters in Iraq and Afghanistan, it is especially hard, according to Lara Logan, the chief foreign correspondent for CBS News. So she has devised a solution when she is talking to the network. "Generally what I say is, 'I'm holding the armor-piercing R.P.G.,'" she said last week in an appearance on "The Daily Show," referring to the initials for rocket-propelled grenade. "It's aimed at the bureau chief, and if you don't put my story on the air, I'm going to pull the trigger.'"

Ms. Logan let a sly just-kidding smile sneak through as she spoke, but her point was serious. Five years into the war in Iraq and nearly seven years into the war in Afghanistan, getting news of the conflicts onto television is harder than ever. "If I were to watch the news that you hear here in the United States, I would just blow my brains out because it would drive me nuts," Ms. Logan said. <More at: www.nytimes.com/2008/06/23/business/media/23logan.html>

'SPECIAL WEAPONS' HAVE A FALLOUT ON BABIES

FALLUJAH, Jun 12 (IPS) - Babies born in Fallujah are showing illnesses and deformities on a scale never seen before, doctors and residents say. The new cases, and the number of deaths among children, have risen after "special weaponry" was used in the two massive bombing campaigns in Fallujah in 2004.

After denying it at first, the Pentagon admitted in November 2005 that white phosphorous, a restricted incendiary weapon, was used a year earlier in Fallujah. In addition, depleted uranium (DU) munitions, which contain low-level radioactive waste, were used heavily in Fallujah. ARMY OVERSEER TELLS OF OUSTER OVER KBR STIR

WASHINGTON — The Army official who managed the Pentagon's largest contract in Iraq says he was ousted from his job when he refused to approve paying more than \$1 billion in questionable charges to KBR, the Houston-based company that has provided food, housing and other services to American troops. The official, Charles M. Smith, was the senior civilian overseeing the multibillion-dollar contract with KBR during the first two years of the war. Speaking out for the first time, Mr. Smith said that he was forced from his job in 2004 after informing KBR officials that the Army would impose escalating financial penalties if they failed to improve their chaotic Iraqi operations.

Army auditors had determined that KBR lacked credible data or records for more than \$1 billion in spending, so Mr. Smith refused to sign off on the payments to the company. "They had a gigantic amount of costs they couldn't justify," he said in an interview. "Ultimately, the money that was going to KBR was money being taken away from the troops, and I wasn't going to do that." But he was suddenly replaced, he said, and his successors — after taking the unusual step of hiring an outside contractor to consider KBR's claims — approved most of the payments he had tried to block. <More at: www.nytimes.com/2008/06/17/washington/17contractor.html>

V.A. BAN ON VOTER DRIVES IS CRITICIZED

Voting rights groups are criticizing the Department of Veterans Affairs for its decision to ban registration drives among the veterans living at federally run nursing homes, shelters for the homeless and rehabilitation centers across the country. Although veterans are not federal employees, department officials based their decision in part on the Hatch Act, which bans federal employees from engaging in partisan political activity.

The department's policy is "to assist patients who seek to exercise their right to register and vote," according to a V.A. directive issued on May 5. "However, due to Hatch Act requirements and to avoid disruptions to facility operations, voter registration drives are not permitted."

Matt Smith, a spokesman for the Department of Veterans Affairs, said the department "wanted to ensure that our staff remains focused on caring for our veterans instead of having to determine the political agenda of each group that might try to enter our facilities." <More at: www.nytimes.com/2008/06/13/washington/13vote.html>

DOD MISLED GOVERNMENT ON NORAD MOVE

COLORADO SPRINGS, Colo. - The Pentagon understated the vulnerability faced by the nation's air and space defense command before it relocated to Colorado's Peterson Air Force Base, a newspaper reported June 16.

The North American Aerospace Defense Command moved from its longtime cave-complex home inside Cheyenne Mountain to Peterson in May. On March 3, military leaders reported to Congress that an assessment of a building at the air base that serves as the nation's homeland security nerve center found "several physical security problems." But The Gazette of Colorado Springs said it obtained a classified document that was even more critical. According to the document, the assessment found "the existing security system at Peterson AFB ... would fail if attacked by even a low level threat."

IN IRAQ TO STAY

It's just a \$5,812,353 contract -- chump change for the Pentagon -- and not even one of those notorious "no-bid" contracts either. Ninety-eight bids were solicited by the Army Corps of Engineers and 12 were received before the contract was awarded this May 28 to Wintara Inc. of Fort Washington, Md., for "replacement facilities for Forward Operating Base Speicher, Iraq." According to a DoD press release, the work on those "facilities" to be replaced at the base near Saddam Hussein's hometown, Tikrit, is expected to be completed by January 31, 2009, a mere 11 days after a new president enters the Oval Office. ARMY PUBLIC AFFAIRS OFFICE OVERSTEPS ITS BOUNDS IN PARTISAN POLITICS

DISABLED SOLDIER RETURNING TO WAR, FACING "STOP LOSS"

One day last August, while manning the .50-caliber gun atop his a Humvee on a dirt road in northern Iraq, Army Spc. Daniel "Joey" Haun suddenly lost consciousness. His vehicle had struck a buried bomb, an "improvised explosive device." Haun was ejected, his vehicle flipped over. On impact with the ground, Haun's left hand was driven up toward his forearm, crushing his wrist. The surgeon who rebuilt the wrist, using a metal plate and screws, told Haun last year that his infantry days were over. The blast also blew out Haun's right ear drum, which required surgery to partially restore his hearing. That surgeon warned him to avoid sustained exposure to any loud noises or risk having to wear a hearing aid.

As to head injuries, a neurologist diagnosed the 24-year-old with post concussive syndrome and mild traumatic brain injury, the likely cause of his daily headaches since the attack. Finally, a psychologist urged Haun to get counseling for his post-traumatic stress symptoms or they could devolve into Post-Traumatic Stress Disorder, a more debilitating condition. So while recuperating in a wounded warrior unit at Schofield Barracks, Hawaii, Haun regularly saw a psychologist. He takes the drug Tramadol for his migraine headaches and Elavil, an anti-depressant, to ease his stress.

Adding to Haun's stress is this surprising news: he's returning to Iraq.

Though Haun expected to be separated or retired on disability, Army doctors have cleared him for transfer back to his infantry unit, Delta Company, 2nd Battalion, 27th Infantry Regiment, 3rd Brigade of the 25th Infantry Division.

OUR VETS: HOMELESS, BROKEN AND ALONE

His lifelong dream of becoming a soldier had, in the end, come to this for Isaac Stevens: 28, penniless, in a wheelchair, fending off the sexual advances of another man in a homeless shelter. Stevens' descent from Army private first-class, 3rd Infantry Division, 11 Bravo Company, began in 2005 — not in battle, since he was never sent off to Iraq or Afghanistan, but with a headfirst fall over a wall on the obstacle course at Fort Benning, Ga. He suffered a head injury and spinal damage.

The injury alone didn't put him in a homeless shelter. Instead, it was military bureaucracy — specifically, the way injured soldiers are discharged on just a fraction of their salary and then forced to wait six to nine months, and sometimes even more than a year, before their full disability payments begin to flow.

"When I got out, I hate to say it, but man, that was it. Everybody just kind of washed their hands of me, and it was like, 'OK, you're on your own,'" said Stevens, who was discharged in November and was in a shelter by February. He has since moved into a temporary San Antonio apartment with help from Operation Homefront, a nonprofit organization.

'HE SHOULD NEVER HAVE GONE TO IRAQ'

Pvt. David Dietrich had a history of cognitive problems. He struggled in boot camp at Fort Knox, Ky., striking at least one of his superiors as unfit for the military. Dietrich was so slow at processing new things, some fellow soldiers called him Forrest Gump. His squad leader, Pfc. Matthew Berg, says Dietrich couldn't hit targets on the rifle range and had trouble retaining information. "He was very strong physically, but mentally he wasn't really all there," Berg says. Recruited as a cavalry scout, one of the toughest specialties in the Army, Dietrich seemed to lack the essential skills for the job: concentration, decisiveness and the ability to move around without being noticed. He was sent for psychological evaluations at least twice, yet somehow Dietrich advanced—from Fort Knox to Germany and on to Iraq in November 2006. Eight weeks later, at 21, Dietrich was killed by a sniper while conducting reconnaissance from an abandoned building in Ramadi.

What was a guy like Dietrich doing in the military? At a time when an overstretched Army is sending into combat thousands of soldiers who once would have been considered mentally or physically unfit for duty, his story illuminates the complexities and human cost of the war—and shows how hard it is to find the line between tragic circumstances and military misconduct.

GI BILL FOR THE 21ST CENTURY

Congress has revamped the GI Bill for military members (including active duty, Reserves, and National Guard), who have at least 90 days of active duty service after September 11, 2001. The new program, commonly referred to as the "GI Bill for the 21st Century," offers substantial increases in monthly education benefits. The post 9/11 program goes into effect on August 1, 2009 and includes provisions to pay full tuition, \$1,000 per year for books and supplies, and a monthly housing stipend.

The new bill actually goes into effect during the 2008/2009 school year, but Congress has given the Department of Veteran Affairs (VA) until August 1, 2009 to publish the new rates (which depends on the state one is attending college in). However, veterans eligible for the new program, who are currently going to school under the Montgomery GI Bill (MGIB) will see their monthly rate increase to \$1,321 (\$200 per month more than the current GI Bill). "The VA must immediately suspend this study until a comprehensive review of the safety of the protocol is conducted," said Rep. Filner.

Rep. Filner along with Rep. Ed Markey (D-MA) and Rep. IRS SEEKING RETIREES AND DISABLED VETERANS FOR STIMULUS PAYMENT

The Internal Revenue Service today announced a campaign to reach those retirees and disabled veterans who qualify stimulus payment but have not filed to claim it. New statistics indicate about 74 percent in this group are accounted for in the stimulus payments currently being sent, leaving about 5.2 million potential recipients remaining.

For all taxpayers, the IRS has issued 76.5 million payments worth \$63.8 billion based on 2007 tax returns processed so far. The agency expects to issue 124 million payments to Americans by year's end. Eligible individuals are receiving up to \$600 (\$1,200 for married couples filing joint returns) plus \$300 for eligible children younger than 17.

A special stimulus category includes recipients of certain benefits from Social Security and Veterans Affairs who do not normally have a requirement to file a tax return. These individuals must file a tax return before Oct. 15 this year to receive their stimulus payments.

... Qualifying income includes any combination of earned income, nontaxable combat pay and certain benefit payments from Social Security, Veterans Affairs and Railroad Retirement.

People not otherwise required to file an income tax return should file Form 1040A with basic information to ensure they receive the economic stimulus payment.

... The types of Veterans Affairs benefits that are considered qualifying income include disability compensation, disability pension and survivor payments.

NATIONAL GUARD AND RESERVE MOBILIZED AS OF JUNE 18, 2008

This week the Army, Navy, Air Force and Marine Corps announced a decrease, while the Coast Guard number remained unchanged. The net collective result is 1,566 fewer reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 87,113; Navy Reserve, 5,476; Air National Guard and Air Force Reserve, 12,017; Marine Corps Reserve, 8,994; and the Coast Guard Reserve, 784. This brings the total National Guard and Reserve personnel who have been activated to 114,384, including both units and individual augmentees. Veterans Upward Bound (VUB) is a free U.S. Department of Education program designed to help eligible U.S. military veterans refresh their academic skills so that they can successfully complete the postsecondary school of their choosing.

ELIGIBILITY: In order to be eligible for participation in a VUB program an individual must be a low-income and/or first-generation college (meaning that neither of your parents have a four-year college degree) student, having served at least 180 days of active federal service, and have a discharge that is OTHER than dishonorable.
