### WHEN DOES THE FAIRNESS START?

John Rawls, in his *“Justice as Fairness”*, posits a social contract that is arrived at by equal partners, equally informed, who operate behind a “veil of ignorance”. He means by this that they write the contract – the rules – so that they apply to all equally, without knowing where they or their constituents will fall in the basic social order when the contract takes effect.

Thus, a person writes fair rules with his contractual partners and does not know until he leaves the meeting whether he will be wealthy or poor, white or black, tall or short, male or female, religious or secular, straight or gay, abled or disabled, etc. – in other words, he or she is ignorant of his or her own position in society while writing the rules. This is of course an idealistic view and cannot practically be true completely, but it is the idea behind what most of us believe, or at least wish the rules to be, both as written and as executed.

Maybe that’s what got many tempers up over this last few weeks when we saw a man convicted of perjury in a case that involved a suspicion of treason having his sentence commuted to fines and no prison, while throughout the country, daily, men and women are going to prison for extended periods for the mere possession of small amounts of certain drugs, and for other minor felonies.

Recently we have seen a young marine called back from civilian life to have his honorable discharged stripped from him – adversely affecting his employment possibilities for the rest of his life, because he allegedly violated an active duty regulation when not on active duty. Yet the perjurer gets off scot free, with his fines undoubtedly paid by some 527, and probably with at least one book contract and a high-paying job at some foundation for the rest of his life.

The score: **Free speech 0 – Abetting treason 1.**  
The real score: **Fairness 0 – Privilege 1**

We veterans live in a nation where insufficient funds can be found to take care of those who have taken on the heaviest burden in defending our society, while those who exploit our society are festooned with subsidies and tax breaks. Those who go keep on paying, while those who stay behind rake it in.

The administration, which operates under policies established by one who is also Commander-in-chief of the forces, states repeatedly that

veterans’ benefits are too expensive, and fights to increase medical co-payments and prescription costs for veterans because otherwise “the benefits will become unaffordable”. That same administration fights to protect inherited money and states that the tax burden on the already wealthy is unfair, supporting such things as taxing the interest on the money your wealthy Daddy left you at a lower rate than ordinary citizens’ wages and salaries.

The Congress does little better since it fails to stand up for fairness for veterans other than occasionally passing a resolution praising their sacrifice. Pardon me if I don’t cheer.

Most recently both the administration and Congress have been saying that serving military and veterans should not complain; after all, enlisted military salaries are supposedly at the sixtieth percentile for their age group, which means that a sergeant makes about what a journeyman mechanic makes. No mention of the difference in risk – the difference in lifetime earnings – the sacrifice of serving military and their families – the deadly danger for serving military on the one hand, and the possible blister the mechanic might get. Some veterans, not all, get medical benefits. Administration executives, congresspersons and their staffs, and their many friends all get those benefits. Some veterans who have served for many years get pensions – not the kind of pensions that the friends of the administration and Congress get, but pensions nonetheless.

All societies – all nations have histories of neglecting the veteran. He or she is their “hero” when there is some fighting to do, and he or she is their “burden” when the fighting is done. But lately it has been getting worse. We are in a non-war – a battle for which the purpose cannot be stated, and for which the objective, thus the end point, cannot be defined. At the least we should take care of those who fight and their families. No memorials – no parades – no speeches – no promises. Action! Purpose! Above all – fairness!

### **LAWMAKERS PUSH FOR BETTER VETERANS CARE**

Congress members on Friday urged a presidential panel to use its sway with President Bush to finally solve years of problems with veterans health care. In its last public hearing before considering recommendations, the nine-member Commission on Care for America's Returning Wounded Warriors heard testimony about legislative efforts to fix gaps in the system.

Many of the commissioners said they wanted to ensure that families could have free access to private medical care if no adequate government facility is available in their home areas. ### **MARINES' REQUEST FOR LASERS MORPHS INTO 2-YEAR BATTLE**

WASHINGTON — Two years ago, Marines in Iraq asked for an emergency order of 200 nonlethal lasers to keep innocent Iraqis from being killed when they fail to stop at U.S. military checkpoints. When the lasers hadn't arrived by last fall, a frustrated lieutenant colonel named Marty Lapierre dipped into a special fund and requisitioned 28 of the devices, which temporarily blind — and therefore stop or redirect — unwelcome drivers. But those handheld lasers, called the CHP [Laser Dazzler](#), didn't make it to the troops, either.

Just before Christmas, Marine generals told Lapierre and Marine science adviser Franz Gayl to shelve the lasers because they were unsafe — even though the Army and Special Forces were using them. Instead, in March, Marine brass shipped a competing laser called the GBD-III, or [Green Beam](#), which is made by B.E. Meyers & Co. in Redmond. Gayl and some Marine officers said the Dazzler, with its wider beam, is much better for the Marines' purposes. #### **US MILITARY BETS ALL ON IRAQ CAMPAIGN**

Under mounting political pressure at home, the US military is betting all that a summer-long campaign against Al-Qaeda in Iraq will leave it in a position to begin drawing down US troops by early next year. General David Petraeus, the US commander in Iraq, has only three months to bring about a major change in security conditions, a goal that has eluded all his predecessors. Should he fall short, analysts say, an angry Congress is almost certain to act to take matters into its own hands.

#### **PETRAEUS: HIGH PROFILE ATTACKS EXPECTED**

BAQOUBA, Iraq - Sunni extremists may try a series of high-profile attacks ahead of a September report to Congress on progress in Iraq, the top U.S. commander said Saturday, recalling the Tet offensive that torpedoed support for the Vietnam War.

"We expect they will try this - pull off a variety of sensational attacks and grab the headlines to create a `mini-Tet,'" Gen. David Petraeus told The Associated Press.

## **STORY WRONG ABOUT IRAQ PULLBACK, WHITE HOUSE SAYS**

WASHINGTON (CNN) -- President Bush's spokesman on Monday denied a published report that described intensifying debate among White House officials over whether to begin a gradual pullback of U.S. troops in Iraq. White House spokesman Tony Snow said a story in The New York Times about a proposed "gradual withdrawal" of forces in "high-casualty neighborhoods in Baghdad and other cities" is "way ahead of the facts."

"There is no intensifying discussion about reducing troops," said Snow during his daily briefing for reporters. He said the so-called "surge," or increase of nearly 30,000 U.S. troops in Iraq, has been complete for only a matter of weeks.

"The surge is not an open-ended commitment, it's not an occupation," said Snow. "It's a surge ... to create space so that we can achieve as swiftly as possible some of those basic necessities for the Iraqi people to be able to step up and stand in the lead. And then at that point, the Americans step back into less visible, more support positions." <More at:

## **OFFICIAL: IRAQ GOV'T MISSED ALL TARGETS**

### REPORT: WARS COST US \$12 BILLION A MONTH

WASHINGTON (AP) - The boost in troop levels in Iraq has increased the cost of war there and in Afghanistan to \$12 billion a month, and the total for Iraq alone is nearing a half-trillion dollars, congressional analysts say. All told, Congress has appropriated \$610 billion in war-related money since the Sept. 11, 2001, terror assaults, roughly the same as the war in Vietnam. Iraq alone has cost \$450 billion. The figures come from the nonpartisan Congressional Research Service, which provides research and analysis to lawmakers. For the 2007 budget year, CRS says, the \$166 billion appropriated to the Pentagon represents a 40 percent increase over 2006. ## THINK THIS MIGHT MAKE IT A LITTLE WORSE YET?

### U.S. NAVY SENDS THIRD CARRIER TO FIFTH FLEET REGION

MANAMA (Reuters) - The U.S. Navy said on Tuesday it had sent a third aircraft carrier to its Fifth Fleet area of operations, which includes waters close to Iran, whose row with the West over its nuclear plans has stoked regional tensions. The carrier will join two aircraft carriers already in the area, which recently gave the U.S. Navy its biggest presence in the Gulf since the Iraq war in 2003, a Navy spokeswoman said.

"(The carrier) Enterprise provides navy power to counter the assertive, disruptive and coercive behaviour of some countries, as well as support our soldiers and marines in Iraq and Afghanistan," a U.S. Navy statement said.

#### **Colonel's Essay Draws Rebuttal From General; Captains Losing Faith**

Last December, Lt. Col. Paul Yingling attended a Purple Heart ceremony for soldiers injured in Iraq. As he watched the wounded troops collect their medals, the 41-year-old officer reflected on his two combat tours in Iraq. He was frustrated at how slowly the Army had adjusted to the demands of guerrilla war, and ashamed he hadn't done more to push for change. By the end of the ceremony, he says, he could barely look the wounded troops in the eyes. Col. Yingling just had been chosen to lead a 540-soldier battalion. "I can't command like this," he recalls thinking.

He poured his thoughts into a blistering critique of the Army brass, "A Failure in Generalship," published last month in Armed Forces Journal, a nongovernment publication. "America's generals have been checked by a form of war that they did not prepare for and do not understand," his piece argued. ([Read the article.](#)) The essay rocketed around the Army via email. The director of the Army's elite school for war planners scrapped his lesson plan for a day to discuss it. The commanding general at Fort Hood assembled about 200 captains in the chapel of that Texas base and delivered a speech intended to rebut it.

"I think [Col. Yingling] was speaking some truths that most of us talk about over beers," says Col. Matthew Moten, a history professor at West Point who also served in Iraq. "Very few of us have the courage or foolhardiness to put them in print."

### ARMY MISSES RECRUITING GOAL AGAIN, RAISES WORRY

WASHINGTON (Reuters) - The U.S. Army, strained by wars in Iraq and Afghanistan, missed its recruiting goal for the second straight month in June, indicating a trend that some defense officials on Monday called worrying. The Army will announce the monthly data on Tuesday. Army spokesmen would not discuss the specific figures. But some defense officials said the Army significantly missed its June goal of 8,400 recruits. One official placed the shortfall at about 15 percent, a major gap for a typically strong month when recruiters normally find more willing young people fresh from high school graduation.

**LITTLE EFFORT MADE TO FIND DESERTERS**

FORT BRAGG, N.C. - There is no crack team of bounty hunters, no elite military unit whose job is to track them down and bring them in. Despite a rise in desertions from the Army as the Iraq war drags on into a fifth year, the U.S. military does almost nothing to find those who flee and rarely prosecutes those it gets its hands on. An Associated Press examination of Pentagon figures shows that 174 troops were court-martialed by the Army last year for desertion - a figure that amounts to just 5 percent of the 3,301 Soldiers who deserted in fiscal year 2006. ### **1,800,000 U.S. VETERANS HAVE NO HEALTH CARE**

As the nation struggles to improve medical and mental health care for military personnel returning from Afghanistan and Iraq, about 1.8 million U.S. veterans under age 65 lack even basic health insurance or access to care at Veterans Affairs hospitals, a new study has found.

The ranks of uninsured veterans have increased by 290,000 since 2000, said Stephanie J. Woolhandler, the Harvard Medical School professor who presented her findings yesterday before the House Committee on Veterans Affairs.

About 12.7 percent of non-elderly veterans -- or one in eight -- lacked health coverage in 2004, the most recent year for which figures are available, she said, up from 9.9 percent in 2000. Veterans 65 and older are eligible for Medicare. About 45 million Americans, or 15 percent of the population, were uninsured in 2005, the Census Bureau reports.

### **AT CAMP, MILITARY KIDS BEAR SCARS OF THEIR OWN**

SAN JUAN CAPISTRANO, Calif. — Twilight fell over the mountain camp as the group formed a circle to trade war stories: the nightmares of battle that wake them in their sleep. The fighting. The pain. The surgeries. And always, the sudden mood swings.

"Sometimes, we feel like we have to run away," Alex Cox says.

"The military's stupid!" Adam Briggs declares.

Alex, 13, and Adam, 12, have never been to war, but they are no strangers to the ravages it can inflict. Their fathers were injured in Iraq. Like 13 other boys and girls ages 7 to 14 at an unusual summer camp this week for children of injured troops, they are in a generation indelibly marked by war.

Nearly 19,000 U.S. children have had a parent injured in the military since Sept. 11, 2001, the Pentagon says. ### **BUDGETEERS QUESTION PAY RAISE BOOST**

The House and Senate Armed Services Committees have both endorsed a small improvement over the Pentagon proposed 3% military pay raise for 2008. Both agreed with MOAA and The Military Coalition that Congress hasn't yet eliminated the pay gap caused by decades of capping military raises below private sector pay growth, and bumped the 2008 raise to 3.5%. The House of Representatives went a step further, approving a plan to reduce the current 3.9% shortfall by one-half percentage point a year for the next five years.

Now, the Congressional Budget Office (CBO) has issued a report questioning whether there's any shortfall to fix. They say their pay comparisons put the average enlisted member in the top 25-30% of equivalent civilian workers' earnings. CBO also cites various studies that claim average enlisted pay actually amounts to \$90,000 to \$138,000 a year, once the cost of all military and veterans' benefits is added in. <More at: <http://www.moaa.org/Legislative>>

### **MEDICARE PROPOSES NEARLY 10% CUT IN PAYMENTS TO DOCTORS**

### **MILITARY STIFLES WEB-BASED HEALTH RECORDS SYSTEM**

Two Defense Department medical agencies have attempted to stall the deployment of a popular Internet-based health records system in favor of pursuing their own systems costing hundreds of times as much, according to congressional sources and documents furnished to Government Executive.

Defense's Military Health System and the Army Medical Department have tried to keep Army clinicians in Iraq and health officials at the Veterans Affairs Department in the United States from using the Joint Patient Tracking Application system and the Web-based Veterans Tracking Application system. The two systems provide doctors and other clinicians with real-time access to a soldiers' electronic health records, from the moment a clinician at a combat hospital enters health information on a wounded soldier until the soldier is released from care in the United States. <More at: <http://www.govexec.com/dailyfed/0607/062707bb1.htm>>

## TAPS – PASSINGS AND WAR STATISTICS

### NATIONAL GUARD AND RESERVE MOBILIZED AS OF JULY 5, 2007

This week, the Army, Navy and Air Force announced an increase, while the Marine Corps had a decrease. The Coast Guard number remained the same. The net collective result is 367 more reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. Total number currently on active duty in support of the partial mobilization for the Army National Guard and Army Reserve is 76,757; Navy Reserve, 5,093; Air National Guard and Air Force Reserve, 5,942; Marine Corps Reserve, 5,933; and the Coast Guard Reserve, 358. This brings the total National Guard and Reserve personnel, who have been mobilized, to 94,083, including both units and individual augmentees.

##### **Nicholson: Veterans Can Show Pride in Their Service**

WASHINGTON – Secretary of Veterans Affairs Jim Nicholson is urging all veterans across the country to pin on their military medals this Independence Day, July 4, to show their patriotism and pride in their service.

"We want to inspire the American people to recognize and honor the military service of their fellow citizens, and to engender a greater sense of pride and satisfaction on the part of the veterans for what they did for our country," said Nicholson. "This initiative shines a bright light on millions of our fellow citizens who answered the needs of our nation both in peace and in war."

Nicholson encourages the 24 million living Americans who have served in the armed forces to display their medals on the Fourth of July by pinning them on their civilian clothing over their left breast. Nicholson first urged veterans to wear their military decorations last Veterans Day under a program called "Veterans Pride Initiative."

The Veterans Pride Initiative asks veterans to wear their medals on Independence Day, Memorial Day and Veterans Day, and when attending other patriotic events. ## **ENLISTING CHRIST - NOT ON MY WATCH**

It is with profound sadness that I approach this Fourth of July. Coming from a long line of veterans and speaking as an Honor Graduate from the U.S. Air Force Academy, my decision to challenge our nation's armed forces has been a painful one.

Through my children, three of whom are U.S. Air Force Academy graduates, along with thousands of other military personnel and chaplains, I have learned firsthand of aggressive internal efforts to evangelize our fighting men and women into a narrow branch of Christianity that claims salvation only for the "born-again" few. Having once sworn to defend and protect our constitution, I had no choice but to found the Military Religious Freedom Foundation and mount a full-frontal legal attack against these forces of intolerance waging war on our foundational freedoms.

In the hierarchical subculture of the military, when your immediate superior tells you to fall in line for Christ or face the consequences, responding with "get out of my face, sir or ma'am" is simply not an option. Imagine then how a young soldier might respond to a multiple-star general ordering his staff to create a PowerPoint presentation showing a direct parallel between the Book of Revelation and our movements in Iraq and Afghanistan. Or a four-star general distributing a flyer "urging" attendance at a religious class at a church outside the base, entitled "Jesus Versus Mohammad: an examination of the life of both prophets and why Jesus is superior to all."

Soldiers and chaplains contact me from the frontlines on a daily basis telling of troops who refuse to be evangelized and are then sent to combat zones with higher concentrations of insurrectionists, jihadists, and IEDs. Many battle staff meetings conducted by commanders begin with evangelical prayers. When a captain confronted his full colonel about one such exclusionary prayer, the colonel grabbed his uniform and said, "Captain, you better get this down right now, boy! We're here to spread American democracy and the Gospel of our Lord Jesus Christ!" Rather than exceptions, these seem to be the rule.

Today, 12 percent of Americans are Dominionists. This subset of Christianity is dedicated to enforcing a literalist reading of the Bible, and is our own home-grown band of religious fundamentalists. For decades, they have sought to influence government officials, institutions, and policy, with the stated goal of returning our nation, and the world, to Christ. Over the past 6 years with George W. Bush in office, they have made significant inroads into the upper echelons of the Pentagon and rank-and-file, fueling the crusader-like mentality that lies behind the debacle we face in Iraq and beyond.

On every one of the 737 U.S. military installations in 132 countries across the globe, there is now an "Officers Christian Fellowship" for officers, and a "Christian Military Fellowship" for the enlisted, the goal of both being to "Carry the gospel through the medium of ordinary relationships among the entire military community: all services, all ranks, all Christian traditions, and all searchers. There are other well-funded groups such the Military Ministry, a division of Campus Crusades for Christ, that specifically targets basic training installations to convert vulnerable new recruits, and Cadence Ministries, whose "Strategic Ministry" includes preying on those facing the possibility of "deployment and deadly combat" because "shaken people are usually more ready to hear about God than those who are at ease, making them more responsive to the gospel."

America now has a radicalized version of the Gospel of Jesus Christ that revels in the imminence of End Times, engaging "the machinery of the state," which includes weapons of mass destruction. The goals of Dominionist Christians run counter to everything for which our nation stands. Their vision of a spiritually transformed U.S. military, with Ambassadors for Christ in uniform, "empowered by the Holy Spirit," is not one with the religious freedom our founding fathers intended.

The First Amendment is under attack and if the wall separating church and state crumbles, nothing else will matter. It won't matter how the Dallas Cowboys do or if Intelligent Design is taught in Kansas. Nothing will matter if we lose the U.S. military to this toxic brand of fundamentalism. On this July 4th, instead of fireworks, I'll be hearing Sinclair Lewis' words thundering in my head, "Let me tell you something. I've seen fascism up close and personal. . . . Not if, but when, it comes to America, fascism will be wrapped in the American flag carrying a cross."
